## **ORDER**

**WHEREAS**, in the wake of outbreak of novel coronavirus disease (COVID-19), declared as a pandemic by World Health Organisation, a lockdown was announced in the country for 21days upto 14<sup>th</sup> March, 2020, in order to contain the spread of the said virus;

AND WHEREAS, an order dated 06.04.2020 was issued u/s 144 of Cr.Pc,1973 stating that any person with Flu like symptoms shall report to the nearest health care facility such as Primary Health Centre, Community Health Centre, Sub District Hospital and Shri Vinoba Bhave Civil Hospital, which shall then be intimated by Medical Officers of PHCs, CHCs, SDHs, SVBCH and Private Hospitals to the Director, Medical and Health Services for taking necessary action as per the Ministry of Health and Family Welfare guidelines;

**AND WHEREAS**, Ministry of Home Affairs, GOI has directed all States/UT's vide order no. at Ref. 7 that the existing lockdown measures to contained the spread of Covid-19 will continue upto 03<sup>rd</sup> May, 2020;

**THEREFORE**, under the section 34 (m) of the Disaster Management Act, 2005, it is hereby ordered that all industries functioning shall report any person -staff or employee within their premises having fever, cough or cold or any type of illness /sickness to the nearest Primary Health Centre, Community Health Centre, Sub District Hospital or Shri Vinoba Bhave Civil Hospital, without any delay. The industry shall maintain separate records/register of such persons and make it available to any government official directed to carry on inspection or visit for any further action;

Failure to comply the said order shall be treated as an offence by the industry and shall be liable for punishment under the section 51 of the Disaster Management Act, 2005.
