Whereas, it has been made to appear to me that "The Haryana Epidemic Disease, Covid-19 Regulations, 2020 have been notified under Epidemic Disease Act. 1897, for the purpose of prevention and control of the outbreak of epidemic namely COVID-19 in District Gurugram. Keeping in view the emergent scenario it is necessary to issue an order for the safety of general public & to avoid any outbreak of an epidemic.

Now, therefore in exercise of the powers vested in me by virtue of "The Haryana Epidemic Disease, Covid-19 Regulations, 2020" notified under Epidemic Disease Act. 1897, I, Amit Khatri, IAS, District Magistrate, Gurugram do hereby suspend the following activities in District Gurugram till 31st March, 2020:-

- (i) The operations of all Gymnasium, Swimming Pools and Spas.
- (ii) The operations of all Night Clubs, Lounges & Bars, Cinema Halls, Theatres, Multiplexes.
- (iii) The operations of all Weekly Bazaars, Shopping Malls, (except Pharmacies & Medical Establishments, Grocery stores and Super Markets).
- (iv) Any gathering such as Social/Cultural/Political/Religious/Academic/Sports/Seminar/Conferences and Family Mass gathering (including marriages) is restricted to maximum of 50 persons.
- (v) All restaurants having in-dining facility is restricted to the capacity of 50 seats or more.
- (vi) The public dealing at government offices should be minimized while not impacting time-bound & essential services.
- (vii) Owner of Saloons, Beauty Parlours, Grooming Centres are directed to decontaminate & sanitize their premises frequently and regularly and ensure availability of hand sanitizer at entry gate.
- (viii) Private Cab Operators are directed to decontaminate & sanitize their cabs frequently and regularly and ensure availability of hand sanitizer in cabs.

This order shall come into force with immediate effect till 31-03-2020.

Any person contravening this order shall be punishable u/s 188 of Indian Penal Code. Commissioner of Police, Gurugram shall implement this order.

In view of requirement of the situation which has become emergent, this order, is being passed ex-parte. It shall be published for the information of public through the press and publicity van of public relations department and by affixing copy at notice board of District Courts, MCG, Zila Parishad, Sub Division, Tehsil, MCs, Panchayat Samiti, Police Stations.
