

Multiple references are being received from various industrial and commercial establishments across the State on a regular basis seeking approvals for operationalization of industrial and commercial establishments engaged in production/ services of essential commodities.

To ease the application requirements for applicants and streamline the processes for providing such approvals, an online service i.e. "Application to resume operations of Industrial/ Commercial Establishment during Lockdown/Curfew (Service)" has been created on Saral Haryana portal (<https://saralharyana.gov.in/>). Enterprises requiring permissions for operations of their establishments may register on the Saral Haryana Portal and further may apply online for the permissions.

In this regard, you are advised to process the applications received through the Saral Haryana portal for seeking approvals of operation of establishments during lockdown/ curfew. It is also advised to ensure that the permissions granted through the portal should be in compliance with the guidelines issued by the Ministry of Home Affairs, Government of India.


