**Night Curfew Imposition**

Dated 31<sup>st</sup> May 2020

1. Whereas, the MHA Govt. of India vide its order No. 40-3/2020-DM-1(A) dated 30.05.2020 has decided to open the lockdown in a phased manner. I, Amit Khatri, IAS, District Magistrate Gurugram invoking the powers conferred under Section 144 CRPC. I do hereby prohibit the following in the interest of maintenance of public health, hygiene and safety in view of the COVID-19 pandemic.
2. Movement of any individual whatsoever for non essential purposes shall henceforth remain restricted between 09:00 PM to 05:00 AM within in the district w.e.f midnight 31.05.2020 to 30.06.2020. Persons above the age of 65, persons having co-morbidities, suffering from chronic diseases, pregnant women and children below the age of 10 years shall avoid coming out in open except in the case of a medical emergency or essential requirement as specified in the national directives.
3. The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates/ Police Officials on duty and any violation of the same shall be strictly dealt with as per sections of 188, 269 and 270 of the Indian Penal Code, 1860.
4. The order shall be promulgated by uploading it on the District website, circulating it through WhatsApp groups, and on other mediums of social/ digital media. Whenever the same is not possible through these methods, means of mass communication like radio, television may also be used and publicity vans be also deployed to disseminate the same.
