## ORDER UNDER SECTION 144 Cr. P.C.

This Order is being issued in continuation to Order qua 'Curfew' issued by the undersigned on dated 24th March 2020 and all related subsequent orders issued till date.

WHEREAS, the National Disaster Management Authority (NDMA), in the exercise of the powers under section 6 (2) (i) of the Disaster Management Act, 2005 has issued an Order No. 1-29/2020-PP dated 01.05.2020 directing the Chairperson of the National Executive Committee (NEC) that lockdown measures be continued to be implemented in all parts of the Country, for a further period of two weeks with effect from 04.05.2020. In furtherance of which, the Ministry of Home Affairs, Government of India vide Order No. 40-3/2020-DM-1(A) dated 1st May, 2020 has issued new guidelines to be followed during the extended period of Lockdown,

AND WHEREAS, the Chief Secretary cum Chairperson, State Executive Committee (SEC), Himachal Pradesh, vide Order No. Rev (DMC) (C) 20-2/2020-COVID19 dated 02<sup>nd</sup> May 2020 has directed all the District Magistrates in the State to ensure strict implementation of the directions of the NDMA and NEC.

THEREFORE, keeping in view the Guidelines of the Ministry of Home Affairs, Government of India and directions of the Chief Secretary cum Chairperson, State Executive Committee, Himachal Pradesh, I, K.C. Chaman, (IAS) District Magistrate, Solan (Himachal Pradesh) in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, do hereby order that en, Diett Golan (H.P.) CURFEW imposed within the entire territorial jurisdiction of District Solan, Himachal Pradesh shall remain to be continued till further orders. It is further ordered that now the Curfew relaxation hours shall be from 10:00 A.M to 03:00 P.M and there are certain modifications to the previous Curfew Orders, which are enumerated below:

> 1. Government Offices will operate as per Orders issued by the Department of Personnel, Government of Himachal Pradesh.

- 2. Private offices shall remain open during Curfew relaxation hours, subject to the condition of engaging 33% staff only.
- 3. Inter State, Inter & Intra District plying of buses will continue to be prohibited till further orders.
- 4. There shall be unrestricted movement of private vehicles (four-wheelers) within the District Solan, subject to odd and even number pattern. On odd dates (e.g. 1, 3, 5, 7, 9...) vehicles having odd digit at the end of its registration number shall ply. Whereas, on even dates (e.g. 2, 4, 6, 8, 10...) vehicles having even digit at the end of its registration number shall ply. However, this odd-even pattern shall not be applicable to the Government vehicles, vehicles on Government duty, permitted vehicles engaged with essential services and Industrial Units, and two wheelers.
- 5. Distilleries, Breweries and Bottling Plants, being Industrial Units involving 'continuous process' shall be exempted from the Lockdown.
- 6. Home Delivery of essential goods/medicines shall be between 02:00 P.M to 05:00 P.M.
- 7. Supply of Essential commodities/Goods shall be received by the vendors between **08:00 A.M** to **10:00 A.M** with half shutter open.
- Shops in Rural areas shall continue to remain open in accordance with Order No. SLN/Reader/DM/1-14/89-IV- 4457 dated 26<sup>th</sup> April, 2020.
- 9. In addition to already exempted commercial activities/shops in Municipal/Urban areas, now following commercial activities/ opening of shops shall also be allowed during Curfew relaxation hours as per days mentioned below:

Further, following shops/establishments shall remain open on all days (Monday to Saturday) during curfew relaxation hours, i.e. 10:00 A.M to 03:00 P.M:

- 1. Drycleaners and washer-man.
- 2. Halwai, Sweet Shops, Restaurants, Pizza Shops, Dhabas. However, only counter sale/take away and home delivery is allowed. No eating & service would be permitted.
- 3. Liquor vendor shops, except all Aahatas & Bars.

NOTE: All shops/markets shall remain closed on Sunday till further Orders.

Further, following restrictions shall remain operative for the well being and safety of persons:

- (i) The movement of individuals, for non-essential activities, shall remain strictly prohibited between 07:00 P.M to 07:00 A.M.
- (ii) No person shall step out without wearing masks and shall use sanitizers frequently.
- (iii) Norms of social distancing shall be followed at public places and work places without any laxity. Over-crowding shall be avoided.
- (iv) Persons above 65 years of age, persons with co-morbidities, pregnant women, and children below the age 10 years, shall stay at home, except for meeting essential requirements and for health purposes, as per the National Directives.
- (v) Sale by e-commerce companies shall continue to be permitted only for essential goods.
- (vi) Sale of Paan, Gutka, Chewing Gums shall continue to remain prohibited
- (vii) Barbers shops, Spas, Beauty Parlours, Gymnasiums, Swimming Pools, Snooker Parlours (Pool-table), Shopping Malls and Shops in market complexes shall continue to remain closed.
- (viii) Construction work shall continue to be permitted (where workers are available on site) from 08:00 A.M to 06:00 P.M.

**NOTE:** For the COVID-19 management, guidelines to be followed at public and work-places have been specified in **Annexure-A**.

This order shall come into force w.e.f. 04.05.2020 till further orders.

## ANNEXURE-A

## National Directives for COVID-19 Management PUBLIC PLACES

- Wearing of face cover is compulsory in all public places.
- 2. All persons in charge of public places and transport shall ensure social distancing as per the guidelines issued by Ministry of Health and Family Welfare.
- 3. No organization/manager of public place shall allow gathering of 5 or more persons. 4. Marriages related gatherings shall ensure social distancing and the maximum number of guests allowed shall not be more than 50.
- 5. Funeral/last rites related gathering shall ensure social distancing and the maximum numbers allowed not be more than 20.
- 6. Spitting in public places shall be punishable with fine, as may be prescribed by the State/UT local authority.
- 7. Consumption of liquor, paan, gutka, tobacco etc. in public places is not allowed.
- 8. Shops selling liquor, paan, gutka, tobacco etc. will ensure minimum six feet distance (2 gaz ki doori) from each other, and also ensure that not more than 5 persons are present at one time at the shop.

## WORK PLACES

- 9. Wearing of face cover is compulsory in all work places and adequate stock of such face covers shall be made available.
- 10. All persons in charge of work places shall ensure social distancing as per the guidelines issued by Ministry of Health and Family Welfare, both with the work places and in company transport.
- 11. Social distancing at work places shall be ensured through adequate gaps between shifts, staggering the lunch breaks of staff etc.
- 12. Provision for thermal scanning, hand wash and sanitizer preferably with touch free mechanism will be made at all entry and exit points and common areas. In addition, sufficient quantities of handwash and sanitizer shall be made available in the work places.
- 13. Frequent sanitization of entire workplace, common facilities and all points which come into human contact e.g. door handles etc., shall be ensured, including between shifts.
- 14. Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age 10 years shall stay at home, except for meeting essential requirements and for health purposes.
- 15. Use of Arogya Setu app shall be made mandatory for all employees, both private and public. It shall be the responsibility for the Head of the respective Organizations to ensure 100% coverage of this app among the employees
- 16. Large physical meetings to be avoided.
- 17. Hospitals/clinics in the nearby areas, which are authorized to treat COVID-19 patients, should be identified and list should be available at work place all the times. Employees showing any symptom of COVID-19 should be immediately sent for check up to such facilities. Quarantine areas should be earmarked for isolating employees showing symptoms till they are safely moved to the medical facilities.
- 18. Arrangements for transport facilities shall be ensured with social distancing, wherever personal/public transport is not feasible.
- 19. Intensive communication and training on good hygiene practices shall be taken up.
