In the wake of outbreak of COVID-19, the Hon'ble Chief Minister of Tamil Nadu has issued a Press Release on 29.03.2020 that the basic amenities of life like food, shelter and medical facilities of the Inter-State Migrant Workers shall be provided by the respective managements. This should be ensured by the District Collectors. Alternate place of stay should be arranged to the Inter-State Migrant Workers, if the present place is found to be crammed.

- 2. The Commissioner of Labour and the Director of Industrial Safety and Health (FAC) have sent proposals to Government requesting to fix the onus on the Employer / Contractor to ensure such provisions to the Inter-State Migrant Workers engaged in Factories, Building and other construction (BOC) establishments, shops and catering establishments, etc.,
- 3. The Government after careful consideration of the proposals received from the Commissioner of Labour / Director of Industrial Safety and Health(FAC) have decided to fix the following onus on the Employer / Contractor in Factories,

Building and other construction (BOC) establishments, shops and catering establishments, etc.,

- 1. The basic amenities of life like food, shelter and medical facilities of the interstate migrant workers shall be provided by the respective managements (Employer/Contractor in the Factories, Shops and Establishments, Catering Establishments and the Employer/ Contractor in the BOC Establishments).
- 2. Steps should also be taken to ensure that the place of stay of the Inter-State Migrant Workers are spacious enough to maintain social distancing among themselves. Alternate places should be identified, if the present shelter is found to be crammed.
- 3. Respective District Collectors will ensure that the above instructions are followed scrupulously.
