Extension of due date for filing Cost Audit Report

The Ministry of Corporate Affairs on September 27, 2021, clarified that submission of the Cost Audit Report to the Board by the Cost Auditor for FY 2020-21 till October 31, 2021, will not constitute violation under the Companies (Cost Records and Audit) Rules, 2014.

SEBI on September 20, 2021 issued clarifications concerning Circular dated April 28, 2021, on 'Alignment of Interest of Key Employees (Designated Employees) of Asset Management Companies (AMCs) with the Unitholders of the Mutual Fund Schemes' to provide clarity on certain provisions and the applicability of the aforementioned circular.

#### Risk Management Framework (RMF) for Mutual Funds

SEBI on September 27, 2021 issued the Risk Management Framework for Mutual Funds to ensure that such funds render, at all times, high standards of service, exercise due diligence, ensure proper care in their operations and protect the interests of investors. As per the Circular, AMCs shall perform a self-assessment of their RMF and practices and submit a report thereon to their Board along with the roadmap for implementation of the RMF. This exercise must be completed, and the necessary systems must be in place with effect from January 01, 2022.

#### Extension of timelines under Guidelines for Investment Advisers

SEBI on September 30, 2021 extended the following timelines for Investment Advisers (IAs) under the SEBI (Investment Advisers) Regulations, 2013:

- For FY ending March 31, 2021, the IAs shall conduct the annual compliance audit by December 31,
   2021 and submit the adverse findings of the audit, if any, by January 31, 2021
- For FY ending March 31, 2021, IAs shall obtain a certificate from an auditor by December 31, 2021

#### Extension of due dates

The CBDT on September 17, 2021, extended the following timelines:

- Timeline for intimation of Aadhaar number to the IT-dept for linking of PAN with Aadhaar has been extended from September 30, 2021 to March 31, 2022.
- Timeline for completion of penalty proceedings under the IT Act has also been extended from September 30, 2021 to March 31, 2022.
- Timeline for issuance of notice and passing of order by the Adjudicating Authority under the Prohibition of Benami Property Transactions Act, 1988 has also been extended to March 31, 2022.

#### ■ Income Tax (30<sup>th</sup> Amendment) Rules,2021

The CBDT on September 24, 2021 issued the Income Tax (30<sup>th</sup> Amendment) Rules, 2021 extending the applicability of the safe harbor provisions for Assessment Years 2020-21 and 2021-22. The amendment shall be deemed to have come into force from the April 01, 2021.

#### Central Board of Indirect Taxes & Customs (CBIT&C)

#### Effect to recommendations of 45<sup>th</sup> GST Council Meeting

The CBIT&C on September 24, 2021 introduced the CGST (8th Amendment) Rules, 2021 to give effect some of the recommendations of the 45th GST Council Meeting. The amendments bring the following effects:

- Mandatory Aadhar authentication for filing refund claims and applications for revocation of cancellation of registration
- Furnishing of Bank Account Details on GST portal within 45 days of registration
- Relaxation in filing FORM GST ITC-04
- Restriction in the filing of Form GSTR-1
- Bank account for claiming refund shall be the bank account which is in the name of the applicant and obtained on his Permanent Account Number

#### **Agriculture**

#### Insecticides (Third amendment) Rules, 2021

Ministry of Agriculture and Farmers Welfare vide Notification dated September 08, 2021 amended the Insecticides Rules, 1971. The amendment has laid down the following provisions:

- Allowed online sale of insecticides and supply of insecticide to the doorstep of the farmers on fulfilment of the conditions of license under the Insecticides Act, 1968 and the Insecticides Rules, 1971
- Allowed a graduate in Life Science with Chemistry as a subject to obtain license as Pest Control
  Operator; earlier, it was only available to graduates in Agriculture or in Science with Chemistry as a
  subject

#### Fertilizer (Inorganic, Organic or Mixed) (Control) Sixth Amendment Order, 2021

Ministry of Agriculture and Farmers Welfare vide Notification dated September 21, 2021 amended the Fertilizer (Inorganic, Organic or Mixed) (Control) Order, 1985. The amendment has laid down the following provisions:

- Inserted components of Potassium Thiosulphate (K2S2O3) under 'LIQUID FERTILISER' in Schedule I Part A
- Inserted the method of analysis of Zinc Polyphosphate in Schedule II Part B

#### Wholesale and retail

#### Amendment of Import Policy ITC (HS), 2017, Schedule-I

Department of Commerce, Ministry of Commerce, and Industry on September 16, 2021 amended the Import Policy Condition No.5 of Chapter 27 of ITC (HS), 2017 Schedule-I. The amended policy condition restricts import of fuels through IOC by companies having rights for marketing of transportation fuels for products excluding gasoline conforming to standard IS 2796 (ITC HS Code: 27101241) and automotive diesel fuel, not containing biodiesel, conforming to standard IS 1460 (ITC HS Code 27101944).

#### Amendment to Foreign Trade Policy 2015-2020

Department of Commerce, Ministry of Commerce and Industry on September 16, 2021 revised the last date for submitting online applications for scrip-based claims to December 31, 2021 for the MEIS, SEIS, ROSCTL, ROSL and additional ad hoc incentive schemes. The amendment further revises the validity of a Duty Credit Scrip for 12 months from the date of issue.

#### Extension in the Export Obligation period of specified Advance & EPCG Authorizations

Department of Commerce, Ministry of Commerce, and Industry on September 23, 2021 granted extension in Export Obligation (EO) for specified Advance Authorisations and EPCG Authorization till December 31, 2021, without any composition fees subject to 5% additional export obligation on balance exports to be fulfilled. This is in addition to EO extensions facility (upon payment of the composition fees) already provided in Foreign Trade Policy (FTP) or Handbook of the Procedure (HBP).

# Amendment to Service Exports from India Scheme (SEIS) for services rendered in the Financial Year 2019-2020

Department of Commerce, Ministry of Commerce, and Industry on September 23, 2021 amended the Service Exports from India Scheme (SEIS). The amendment puts forth the following guidelines:

- List of eligible services and rates under SEIS for services rendered in the FY 2019-20
- Imposes a limit of INR 5 crore per IEC on total entitlement under SEIS from April 01, 2019 to March 31, 2020
- Excludes services rendered in the FY 2019-20 to claim benefits under SEIS on payments in INR

 Prescribes the deadline for submission of SEIS applications for FY 2019-20 on December 31, 2021 after which the applications will become time-barred

#### Extension of validity of Handbook of Procedures (HBP) 2015-2020

Department of Commerce, Ministry of Commerce, and Industry on September 28, 2021 extended the validity of the Handbook of Procedures (HBP), 2015-20 till March 31, 2022. The amendment further extends the validity of Status Certificate granted under the Foreign Trade Policy (FTP) and the Norms ratified by any Norms Committee (NC) in respect of any Advance authorization obtained till March 31, 2022.

#### Guidelines for the Production Linked Incentive (PLI) Scheme for automobile and auto component industry

Ministry of Heavy Industries on September 23, 2021 published the Guidelines on Production Linked Incentive (PLI) Scheme for automobile and auto components for effective and smooth implementation of the Scheme. The Guidelines include the definitions, eligibility criterion, tenure, method of application, details with regards to Project Management Agency (PMA) and Empowered Committee (EC) as well as calculation and disbursement of incentive for availing the Scheme.

#### Public disclosures by insurers

IRDAI on September 30, 2021 revised the guidelines for public disclosures by insurers. The revised Circular mandates uploading of disclosures on the website every quarter and publishing in newspapers on a half yearly basis from September 30, 2021. The Circular further gives relaxation to the insurers to make the quarterly disclosures in the revised formats for the period ending June 30, 2021, voluntarily on their websites.

# **Extension of timelines for issuance of electronic policies and dispensing with physical signatures on the proposal forms**

IRDAI on September 17, 2021 extended the timeline for the mandatory obtainment of electronic consent of the customer by the insurer on the proposal form in place of physical signatures required earlier and issuance of electronic policies to the customer by the insurer till March 31, 2022.

#### Food and beverages

#### Food Safety and Standards (Labelling and Display) First Amendment Regulations

FSSAI on September 10, 2021 amended the Food Safety and Standards (Labelling and Display) Regulations, 2020. The amendment has laid down the following provisions:

- Dimension of mandatory declarations to be made in food package having surface area up to 30cm2 containing caloric or non-caloric sweetener or mixture
- Inserted the declaration to be made in every package of food containing 10 per cent or more Sorbitol and Sorbitol syrup
- Inserted the declaration to be made in every food article containing Aspartame (Methyl ester),
   Acesulfame Potassium, Aspartame-Acesulfame salt, Sucralose, SACCHARINS, Neotame, Steviol Glycoside and Polyols marketed as 'Table-Top- Sweetener'
- Inserted the manner of labelling for packages containing physically refined Rice bran oil in Vansapati
- Inserted the manner of declaration to be made in packages containing an admixture of edible oils

#### Food Safety and Standards (Fortification of Foods) Second Amendment Regulations, 2021

FSSAI on September 22, 2021 amended the Food Safety and Standards (Fortification of Foods) Regulations, 2018. The amendment has set a tolerance limit of 10 per cent of the declared total value of added micronutrients of fortified foods for compliance and analysis of standards on micronutrient content in fortified foods.

#### Plastic Waste Management (Second Amendment) Rules

Ministry of Environment, Forest and Climate Change on September 17, 2021 amended the Plastic Waste Management Rules, 2016. The amendment has allowed usage of carrying bags made of recycled plastic or products made of recycled plastic for storing, carrying, dispensing, or packaging ready to eat or drink foodstuff subject to the notification of appropriate standards and regulation under the Food Safety and Standards Act, 2006 by the Food Safety and Standards Authority of India.

#### Drugs and Cosmetics (Amendment) Rules, 2021

Ministry of Ayush on September 23, 2021 amended the Drugs and Cosmetics Rules, 1945. The amendment has brought in the following changes:

- Revised the definition of "New Homeopathic Medicine' and prescribed the time till which those medicines should be considered as 'New Homeopathic Medicine' after its approval
- Amended the conditions for grant of license and made it mandatory for the manufacture of Homeopathic medicines to employ a graduate in Science with Botany and Zoology (earlier it was mandatory to employ a graduate in science with only chemistry)

#### **Textiles & leather**

#### Production Linked Incentive (PLI) scheme for textiles

Ministry of Textiles on September 24, 2021 approved the Production Linked Incentive (**PLI**) Scheme for promotion of MMF Apparel, MMF Fabrics and Products of Technical Textiles for 5 years period till FY 2029-30. The Scheme applies to any person including a firm or company willing to invest INR 100 crore or INR 300 crore in Plant, Machinery, Equipment and Civil Works (excluding land and administrative building cost) to produce products of notified lines.

#### Production Linked Incentive (PLI) Scheme for drones and drone components in India

Ministry of Civil Aviation vide notification dated September 30, 2021 approved the Production Linked Incentive (**PLI**) Scheme for drones and drone components in India for three years starting from the Financial Year 2021-22. The scheme applies to all manufacturers of drone and drone components and lays down the mode of implementation of the scheme and method of computation of incentives and financial outlay.

The order shall come into force from September 19, 2021 and shall be effective for a period of sixty days up-to and including November 17, 2021.
