# Securities and Exchange Board of India (SEBI)

 Extension of timeline for entering details of the existing outstanding non-convertible securities in the Security and Covenant Monitoring system

SEBI on October 03, 2022 extended the timeline for entering the details of the existing outstanding non-convertible securities in the Security and Covenant Monitoring system hosted by Depositories by one month. The issuers shall ensure that they enter the details into the DLT system on or before October 31, 2022.

- A financial institution with a local client base in case of any U.S. reportable account
- A local bank, in case of any US reportable account
- A financial institution with only low value accounts, in case of any US reportable account

# Temporary offline registration procedure under Batteries Waste Management Rules, 2022

The Central Pollution Control Board (CPCB) has notified the registration procedure to be adopted for submission of application by the producer or manufacturer of batteries in offline mode to CPCB. It has been informed that the Online Centralized Portal of CPCB, which is the statutory portal for registration as per Batteries Waste Management Rules, 2022, is under development and therefore the following offline mode for submission of applications will be adopted till the time it becomes operational:

- Producer or manufacturer must apply for grant of registration to CPCB by submitting duly filled Form 1(A) through email at batteries.cpcb@gov.in and the hard copy of the application to be submitted to Member Secretary, CPCB at the address specified in the notification.
- The application shall be submitted from company's email ID only.
- Producer or manufacturer must submit the documents proofs along with the application form.
- Registration will be granted initially for a period of 6 months, which will be renewed through online portal once it gets operational.

# Payment of Bonus Act, 1965 applicable to employers in Dadra & Nagar Haveli and Daman & Diu

The Labor Department of Administration of Dadra & Nagar Haveli and Daman & Diu vide Circular dated October 10, 2022 has directed all the industrial and other establishments i.e., hotels, shops etc., labor contractors to pay bonus to all eligible employees in accordance with the provisions of the Payment of Bonus Act, 1965 taking into consideration the productivity of the employee, so that congenial industrial environment could be created leading to overall economic development of the region. The employers shall submit Annual Return in Form D under Payment of Bonus Act, 1965 immediately after making payments of bonus to employees.

# Goa bans Unregulated Deposit Schemes Rules, 2022

The Government of Goa vide gazette notification dated October 03, 2022 issued the Goa Banning of Unregulated Deposit Schemes Rules, 2022. The amendment provides that self-help groups are allowed to make periodic payment of amount up to INR 1000 per month to members. INR 1000 shall be the ceiling limit for providing loan to members of self-help groups.

# Goa Agriculture Produce and Livestock Marketing Promotion and Facilitation (Amendment) Act, 2022

The Government of Goa vide gazette notification dated October 06, 2022 issued the Goa Agriculture Produce and Livestock Marketing Promotion and Facilitation (Amendment) Act, 2022. The amendment provides that Marketing Board shall levy and collect market fee from buyer in respect of notified agricultural produce including livestock bought by such buyer in the principal market yard or submarket yard(s) or market sub-yard(s) or anywhere in the State of Goa either brought from outside the State or from within the State.

# Amendment to the Indian Stamp Act, 1899 as in force in the state of Goa

The Government of Goa on October 12, 2022 issued amendment to the Indian Stamp Act, 1899 as in force in the State of Goa, whereby the following have been amended:

- Clause (i) of the Principal Order has been substituted to provide that 'Reduce the Stamp Duty chargeable on conveyance (not being a transfer charged or exempted under Article No. 62) so far as it relates to immovable property, which is presently specified in Article 22 (b) of Schedule I-A to the said Act, to the scale as specified hereunder:
  - o (a) Where the amount or value of the consideration for such conveyance as set forth therein exceeds INR 600 but does not exceed rupees fifty lakhs, the stamp duty shall be 3%.
  - (b) Where the amount or value of the consideration for such conveyance as set forth therein exceeds rupees fifty lakhs but does not exceed rupees seventy-five lakhs, the Stamp Duty shall be 4%.'

#### Goa Industrial Development (Amendment) Act, 2022

The Government of Goa on October 07, 2022 issued the Goa Information Technology Development (Amendment) Act, 2022 to further amend the Goa Information Technology Development Act, 2007 wherein Section 50 has been substituted for the following:

- Section 50. Penalty for obstruction.
  - Any person who obstructs the entry of a person authorized under Section 35 or any person
    with whom the Corporation has entered into a contract for the performance and execution
    of any act by such person, to enter into or upon any land or building or molests such person
    after such entry or who obstructs the lawful exercise by him of any power conferred by or
    under this Act shall, on conviction by a competent Court, be punished with fine which may
    extend up to fifty thousand rupees.
  - If any person removes any mark set up for the purpose of indicating any level, boundary line, or direction necessary to the execution of works authorized under this Act, he shall, on conviction, be punished with a fine that may extend up to fifty thousand rupees.

# Goa Legal Metrology (Amendment) Rules, 2022

The Government of Goa on October 07, 2022 notified that the Goa Legal Metrology (Amendment) Rules, 2022 to further amend the Goa Legal Metrology Rules, 2011 with the following:

- Amendment has been made to Schedule II which specifies licensing fees and renewal fees for manufacturers, repairers, or dealers of weights and measures.
- Amendment has been made to Schedule III which specifies the fee payable for verification and stamping of weights and measures, weighing and measuring instruments.

# Goa RERA directions for builders and landowners to comply with the real estate project registration requirements

The Goa Real Estate Regulatory Authority has issued a circular directing builders and landowners who intend to get their real estate projects registered to comply with the following legal requirements:

- Furnish registered joint development agreement or collaboration agreement or any other form
  of agreement the registration of which is made compulsory under Section 17 of the Indian
  Registration Act.
- The agreement should be registered with the jurisdictional Sub-Registrar i.e., the Registrar in whose jurisdiction the project is located.
- If such agreement is not submitted within the given time frame, the registration is liable to be rejected.
- Furnish complete conversion sanad while seeking registration of real estate projects

# Instructions to shopkeepers and sellers to record and I.D. proofs of the purchasers while selling certain items belonging to the Army or Police or Paramilitary forces

The Office of the District Magistrate, Chandigarh has ordered an emergency measure where any shopkeeper or seller within the territory of Chandigarh will not sell any cloth or uniform or sticker or flag, or logo attached on cars and any other item belonging to the Army or Police or Paramilitary forces without keeping the record and ID proofs of the purchasers. This order will be in force from September 20, 2022 up to the period of 60 days i.e., November 18, 2022.

# Exemption of certain establishments under Schedule –I of Delhi Shops and Establishments Act, 1954

The Government of Delhi on October 12, 2022 issued an exemption to certain establishments by amending Schedule-I under the Delhi Shops and Establishments Act, 1954. The establishments have been provided exemptions, subject to certain conditions, under the following sections:

- Section 14 states that 'no young persons and women shall work after daytime which is between 9 PM and 7 AM'.
- Section 15 states 'no shop or commercial establishment should open before or close later than the prescribed government time'.
- Section 16 states that every shop and establishment shall remain closed on a 'close day'.

# <u>Direction for construction agencies with respect to dust pollution in their sites in NCR</u> districts of Haryana

The Haryana State Pollution Control Board (HSPCB) has notified the development of an online mechanism through a web portal called Dust Pollution Control Self-Assessment, HSPCB for self-assessment by construction agencies with respect to dust pollution in their sites. All project proponents, contractors, builders, persons or authorities undertaking construction and demolition activities in NCR districts of Haryana are required to mandatorily register on the Web Portal immediately. The following are the directions to be followed by the agencies:

- All current and upcoming projects (on plot area equal to or greater than 500 square meters) of construction and demolition for civil structures, are required to mandatorily register on the web portal.
- To self-monitor or self-audit their activities on the parameters mandated or directed for compliance and to take necessary steps, if required, to improve the status of compliance.
- The provision of video fencing with remote connectivity of the projects (within the municipal area of NCR and plot area equal to or greater than 500 sq m) is part of the portal.

#### Restricted use of firecrackers

The Punjab government clarified on Wednesday that a window of two hours, from 8pm to 10pm, will be open for bursting firecrackers on Diwali, October 24. Apart from Diwali, crackers bursting will be permitted for one hour from 4am to 5am and one hour from 9pm to 10pm on November 8, the 'Prakash Purab' of Guru Nanak Dev. Additionally, only 35 minutes each on Christmas and New Year's Eve from 11.55pm to 12.30am is the permitted slot for bursting firecrackers.

# Revised minimum wages for scheduled employment

The Government of Punjab on October 11, 2022 revised the minimum wages for unskilled workers and for other categories of workers in respect of scheduled employment. The minimum rate of

wages of labor in agriculture (unskilled workers) included with meals or food grains per annum is INR 68194.88 per annum. This has come with effect from September 01, 2022, for their agriculture labor daily wage as of September 01, 2022, which is INR 357.50 with meals and INR 397.46 without meals. The details of the brick kiln (price rate) per 1000 bricks/tiles (in INR) have been mentioned in table No. V is attached to the document.

# Processing Fee for delayed Submission of hardcopy of registration application after issuance of Registration Certificate

The Rajasthan Real Estate Regulatory Authority has issued an order regarding amendment in the Order dated August 27, 2021, which stated directions for compliance by promoters of registered projects. In case of failure to submit the hardcopy of registration application along with all documents, as issued under the above-mentioned directions, dated 2021 within 30 days from date of issue of Registration Certificate (RC), delay processing charges of INR 1000 per day with a maximum capping of an amount twice the registration fee which shall be payable before or at the time of depositing of hardcopy. This shall come into effect from August 27, 2021.

#### Directions for bursting crackers

The Tamil Nadu Pollution Control Board (TNPCB) has issued a press release for the people to celebrate a noiseless, smoke free and safe Deepavali whereby the Tamil Nadu Government has permitted to burst the crackers between 6.00 AM to 7.00 AM and 7.00 PM to 8.00 PM. The following do's and don'ts to celebrate safe and pollution free Deepavali have been suggested:

- Do's
  - o Public shall burst firecrackers of less polluting and low sound generating green crackers.
  - Burst the crackers as community fire cracking in a common place with the permission of district administration or local bodies through the local Welfare Associations etc.
- Don'ts:
  - o Avoid bursting of joined (Series) firecrackers which creates huge noise.
  - Avoid bursting of firecrackers in silence areas like hospitals, schools, courts, and religious places.
  - o Avoid bursting of firecrackers near huts and fire prone areas.

# Draft amendment to Tamil Nadu Motor Vehicles Rules, 1989

- For advance registration number for any class of Vehicle allotted by the Government.
- For allotment of advance registration number for two wheelers and three wheelers by the Registering Authority.
- For allotment of advance registration number for all imported cars and other vehicles by the Registering Authority.

# Ordinance to prohibit online gambling and to regulate online games

The State Government of Tamil Nadu has issued Tamil Nadu Prohibition of Online Gambling and Regulation of Online Games Ordinance, 2022. Key highlights of this ordinance are:

- No person shall make or cause to make any advertisement in any media which directly or indirectly promotes or induces any person to indulge in online gambling or play any online game of chance, with money or other stakes.
- No bank, financial institution or payment gateway provider shall engage in any transaction or authorization of funds towards payment for any online gambling or online game of chance like Rummy and Poker.
- No online games provider shall provide online gambling service or allow playing of any online game of chance, with money or other stakes.
- Violation of the provisions of this ordinance is a punishable offence. It attracts penalty as well as imprisonment.
