Procedure for Registration Certificate for import of Marble and Fresh (green) Areca Nut from Bhutan

The Ministry of Commerce and Industries on March 20, 2023 notified the procedure for application of Registration Certificate for import of Marble under HS Codes 2515 or 6802 and Fresh (green) Areca Nut under ITC(HS) 08028010 without Minimum Import Price (MIP) condition from Bhutan.

Safety Glass (Quality Control) Amendment Order, 2023

The Ministry of Commerce and Industries on March 27, 2023 amended Para 2 of Safety Glass (Quality Control) Order, 2020. As per the Amendment, the Safety Glass (Quality Control) Order, 2020 shall not apply to:

- Import of safety glass by a vehicle manufacturer for manufacturing up to ten thousand vehicles manufactured in India per financial year.
- Import of up to 5,000 number of safety glass per financial year for the purpose of repairs or after sales service of vehicles.

Relaxation with respect to electronic submission of Form 10F

CBDT on March 28, 2023 extended the relaxation to file Form 10F (Self-certificate of foreign exemption) till September 30, 2023 from March 31, 2023.

Income Tax (Fourth Amendment) Rules, 2023

CBDT on March 28, 2023 amended Rule 114AAA of Income Tax Rules, 1962. As per the Amendment, the PAN of any person who failed to link their PAN with Aadhar before March 31, 2022 shall become inoperative, and he shall be liable for payment of fee.

CBDT on March 28, 2023 issued a clarification on Income Tax (Fourth Amendment) Rules, 2023. As per the clarification, the date for linking PAN and Aadhaar has been extended to June 30, 2023. From July 01, 2023, the PAN of taxpayers who have failed to intimate their Aadhaar, as required, shall become inoperative.

Reduction in Special Additional Excise Duty on Petroleum Crude

The Ministry of Finance on March 20, 2023 reduced the Special Additional Excise Duty on Petroleum Crude to INR 3,500 per ton from INR 4,400 per ton and reduced the Duty on Aviation Turbine Fuel to NIL per liter from INR 4.5 per liter.

 Draft Andhra Pradesh Electricity Regulatory Commission (Licensees' Standards of Performance) Fourth Amendment Regulation, 2023

The Andhra Pradesh Electricity Regulatory Commission (**APERC**) on March 20, 2023 published a Public Notice on the Draft Andhra Pradesh Electricity Regulatory Commission (Licensees' Standards of Performance) Fourth Amendment Regulation, 2023 for enhancement of the Service Level Agreement (**SLA**) days for Low tension (**LT**) application processing from the current 7 days to 15 working days.

Order on Tariff for Retail Sale of Electricity during FY2023-24

- The Commission has decided to consider the ARR, FPT, and CSS filings for FY2023- 24 submitted by the DISCOMs as stated briefly in this Chapter, as the basis for the determination of ARR and Tariff for Retail Sale of Electricity for FY2023-24 after duly considering the views/objections/suggestions of stakeholders.
- The Sales, Losses, and Power Purchase requirements are stated.
- The Power Purchase Costs are mentioned.

Andhra Pradesh Industrial Development Policy (APIDP) 2020-2023

The Government of Andhra Pradesh on March 19, 2023 notified Andhra Pradesh Industrial Development Policy (APIDP) 2020-2023 which will remain in force for a period of 4 years, starting from April 01, 2023, till March 31, 2027.

The incentives mentioned in the Policy will be extended to industries as per the operational Guidelines to be notified separately, with the following conditions:

- The total incentives for any company will be restricted to 100% of the Eligible Fixed Cost of Investment (EFCI) (excluding land cost) and limited to 20% in each of the five years.
- Only those brownfield projects where the EFCI and capacity of expansion are greater than 50% will be eligible for incentives.

Goa (Regulation of Land Development and Building Construction) Relaxation Rules, 2023

The Department of Town & Country Planning, Goa on March 16, 2023 issued the Goa (Regulation of Land Development and Building Construction) Relaxation Rules, 2023, wherein the following has been stated:

- The extent to which Regulations can be relaxed has been stated in the Rules.
- Any request made for availing relaxation to the extent as specified in Rule 3
- shall be processed by the Chief Town Planner (Planning) for obtaining the decision of the Government.

Guidance Manual for slaughterhouse and meat processing industries, bone mill, Processing of animal horn, hoofs, and other body parts

The Gujarat Pollution Control Board, (GPCB) on March 24, 2023 issued a Guidance Manual for slaughterhouse and meat processing industries, bone mill, Processing of animal horn, hoofs, and other body parts. As per the manual:

- Applicant shall furnish local body NOC for the slaughterhouse.
- Applicant shall furnish Food Safety and Standards Authority of India (FSSAI) department Registration/License.

 Applicant shall install primary effluent treatment plant to achieve discharge norms and shall also furnish local body permission for the reception of primary treated effluent into their sewers leading to a full-fledged Sewage Treatment Plant.

The Government of Gujarat via Notification dated March 27, 2023 revised the minimum rates of wages payable to the employees employed in sugarcane cutting and loading as INR 476.00 per ton. The rates are effective April 01, 2023.

The Labour, Skill Development and Employment Department, Gujarat on March 27, 2023 revised the minimum wages of employees employed in the appended Scheduled Employment. Following is the class of employee and applicable rates:

- Skilled: INR 474.00 (Zone-I) and INR 462.00 (Zone-II)
- Semi-skilled: INR 462.00 (Zone-I) and INR 452.00 (Zone-II)
- Unskilled: INR 452.00 (Zone-I) and INR 441.00 (Zone-II)

Himachal Pradesh

Issuance of effective date for Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022

Governor of Himachal Pradesh on March 27, 2023 issued an effective date for Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022 as March 28, 2023. The key highlights of Himachal Pradesh Ground Water (Regulation and Control of Development and Management) Amendment Act, 2022 are:

- Every person extracting ground water and does not come in the ambit of definition of user of ground water in a notified area shall make an application for registration of well, to the Authority, in the manner as may be prescribed.
- No unregistered drilling agency or rig owner shall be allowed to construct ground water abstraction structures and in case of default, he will be liable for penalty as specified by the State Ground Water Authority or Central Ground Water Authority.
- In case of contravention of provisions of the Act, the user shall be liable for imprisonment for a term which may extend to five years or with a fine which may extend to ten lakh rupees, or with both.

Jharkhand

Notification regarding the Payee ID deactivation.

The Government of Jharkhand on March 20, 2023 notified regarding the Payee ID deactivation wherein the following process has been prepared by the department to deactivate the payee ID:

- In case of Multiple Payee IDs or Payee ID corrections, Payee will request for Payee ID deactivation to the concerned DDO through a proper letter and ID proof (PAN/GSTIN).
- DDO will verify the request and sends an online request with a forwarding letter and attachments to the concerned treasury for Payee ID deactivation using the DDO's Login in DDO Level Bill Management System.
- Treasury Officer will verify the online request and deactivates the requested Payee ID using the Treasury Officer's Login in Kuber Integrated Online Treasury Information System.

- DDO can view the Payee ID deactivation status (Pending/Deactivated)/payee using the DDO login in the DDO Level management system.
- The payee will also be intimated with SMS regarding this and the DDOS must ensure that the correct mobile no. is updated in the payee's profile.

Addition of explanation to exemption of the intra-State supply of services

The Commercial Taxes Department, Jharkhand on March 27, 2023 added an explanation under the exempted service of renting of a residential dwelling to a registered person that if the registered person is the proprietor of a proprietorship concern and rents the residential dwelling in his personal capacity for use as his own residence, such renting shall be on his own account and shall not be of the proprietorship concern.

Amendment in the rate of the Jharkhand Commercial Taxes

The Commercial Taxes Department of Government of Jharkhand on March 18, 2023 made the following amendments in the tax rates:

- Commercial Tax of 2.5% on Ethyl Alcohol supplied to oil marketing companies or petroleum refineries for blending with motor spirit (petrol)
- Commercial Tax of 6% on fruit pulp or fruit juice-based drinks
- Commercial Tax of 9% on Ethyl Alcohol and other spirits, denatured, of any strength
- This Notification shall come into force with effect from January 01, 2023.

Addition in exemption of intra-State supplies of goods under Jharkhand Goods and Services Tax Act, 2017

The Commercial Taxes Department, Jharkhand on March 18, 2023 added exemptions of intra-State supplies of goods under the Jharkhand Goods and Services Tax Act, 2017. The following has been added:

- Aquatic feed including shrimp feed and prawn feed, poultry feed and cattle feed, including grass, hay and straw, supplement and additives, wheat bran and de-oiled cake (other than rice bran)
- Husk of pulses including Chilka, Concentrates including chuni or churi, Khanda

This Notification shall come into force with effect from January 01, 2023.

Karnataka

Karnataka Fire Force (Amendment) Ordinance, 2023

The Government of Karnataka on March 24, 2023 issued the Karnataka Fire Force (Amendment) Ordinance, 2023 to further amend the Karnataka Fire Force Act, 1964. As per the Amendment, in Section 13 which states 'Preventive measures', the following have been inserted:

- (3) Any person proposing to construct a high-rise building shall obtain a No Objection Certificate from the Karnataka State Fire and Emergency Services department.
- (4) Subject to the provisions of the National Building Code 2016relating to Fire and life safety, while issuing a No objection certificate for construction of a high rise building, the Karnataka State Fire and Emergency Services department shall follow such procedure and collect such amount of fee as may be prescribed.

Karnataka Transparency in Public Procurements (Amendment) Ordinance, 2023

The Government of Karnataka on March 29, 2023 published the Karnataka Transparency in Public Procurements (Amendment) Ordinance, 2023 to further amend the Karnataka Transparency in Public Procurements Act, 1999 and shall come in force at once. As per the Amendment, in Section 6 which states 'Procurement Entities to follow Procedure' in the first proviso, for the words and figures 'Rs. 50.00 Lakhs', the words and figures 'Rs. 1.00 crore', shall be substituted.

Karnataka Minor Mineral Concession (Amendment) Rules, 2023

The Government of Karnataka on March 17, 2023 published the Karnataka Minor Mineral Concession (Amendment) Rules, 2023 to further amend the Karnataka Minor Mineral Concession Rules, 1994. As per the Amendment, the following are the key highlights:

- Schedule- I which specifies the rates of 'dead rent' has been substituted.
- Schedule II-A that specifies the rate of 'minimum area for grant of quarry lease' has been substituted.

Kerala

<u>Revision in Consumer Price Index numbers for agricultural labourers and industrial</u> workers

The Department of Economics & Statistics, Kerala on March 21, 2023 revised the Consumer Price Index (Cost of Living Index) numbers, updating the rate of variable Dearness Allowance for all the industries in the State of Kerala, with effect from January 01, 2023.

Installation of illegal billboards and banning of single-use plastics

The Department of Local Self-Government, Kerala has issued guidelines on March 21, 2023 incorporating the provisions of various orders regarding the installation of illegal billboards within the local government limits and banning of single-use plastics. The key aspects of the guidelines are as follows:

- Ensure the use of government prescribed 100% cotton plastic free paper, recyclable Poly Ethylene (EPR Registration Number and Expiry), PVC Free Recyclable Logo, unit name and number and certificate number from Pollution Control Board QR Code.
- Ensure not to use PVC flux, polyester, nylon, Korean cloth, plastic coated cloth.
- In case of a complaint from the general public, the complainant shall bear the expenses incurred by the KSPCB in getting the sample tested by the CIPET and Textile Committee.
- Banner and boards containing program details shall be removed by the installers within 7 days of the day following the date of the program and maximum 30 days for advertisement banner boards of organizations etc. without date. Failure to do so, fine of not less than INR 20 per square feet and dismantling charges including removal, transportation charges and processing and disposal charges from the installers shall be levy by Municipal Corporation Gram Panchayat.

Revision in minimum rate of wages in timber cutting, felling and transportation of logs industry

The Government of Kerala on March 18, 2023 revised the minimum rates of wages payable to the employees employed in the timber cutting, felling and transportation of logs industry sector. Furthermore, in addition to the rate of basic wages, the employees shall be eligible for Dearness Allowance calculated on the basis of Consumer Price Index calculated at the rate of INR 2.30 for piece rated employees and daily waged employees and INR 60 for monthly waged employees.

Madhya Pradesh

Draft of amended rules under the Madhya Pradesh Municipal Corporation Act, 1956

The Government of Madhya Pradesh via Notification dated March 24, 2023 proposed the draft of amended rules under the Madhya Pradesh Municipal Corporation Act, 1956, amending Rule 23 by adding a proviso that the urban body may consult the concerned resident association before issuing No Objection Certificate. According to the Notification, any objection or suggestion, which may be received from any person with respect to the said draft of amendment at the office of the Principal Secretary, Urban Development and Housing Department, Government of Madhya Pradesh, Mantralaya, Vallabh Bhawan, Bhopal shall be considered by the State Government.

Fixation of price of cloth supplied by the State Power Loom Cooperative Union

The Government of Madhya Pradesh via Notification dated March 17, 2023 fixed the price of cloth supplied by the State Power Loom Cooperative Union. The rates will be effective in the entire state of Madhya Pradesh for which GST will be payable and Union's dividend has been fixed at 15 %. The rates shall be effective till March 31, 2023, for the financial year 2022-2023.

Madhya Pradesh Nagarpalik Vidhi (Sanshodhan) Adhiniyam, 2023

The Government of Madhya Pradesh via Notification dated March 17, 2023 published the Madhya Pradesh Nagarpalik Vidhi (Sanshodhan) Adhiniyam, 2023 to further amend the Madhya Pradesh Municipal Corporation Act, 1956 and the Madhya Pradesh Municipalities Act, 1961. According to the Amendment, penalty for owner or occupier of a building or land has been changed in Section 195 of Madhya Pradesh Municipal Corporation Act, 1956 as the Commissioner shall impose a fine which may extend to INR 5,000 and further additional fine which may extend to INR 200 per day till the work mentioned in the notice is not complete.

Madhya Pradesh Electricity Regulatory Commission (Verification of Captive Generating Plants and Captive Users) Regulations, 2023

The Government of Madhya Pradesh on March 17, 2023 published the Madhya Pradesh Electricity Regulatory Commission (Verification of Captive Generating Plants and Captive Users) Regulations, 2023 for verification of the captive status of Generating Plants and Captive Users. These Regulations will apply to all the Captive Generating Plants (**CGPs**) and extend to the whole State of Madhya Pradesh. These Regulations will come into force from March 17, 2023.

Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Tariff) (1st Amendment) Regulations, 2021

The Government of Madhya Pradesh on March 17, 2023 notified amendment in Regulation 47 of the Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Tariff for Supply and Wheeling of Electricity and Methods and Principles for Fixation of Charges) Regulations, 2021, which states that 'A consumer situated within the area of supply of a Distribution Licensee availing Open access as per the provisions of Madhya Pradesh Electricity Regulatory Commission (Terms and Conditions for Intra-State Open Access in Madhya Pradesh) Regulations, 2021 as amended from time to time, shall be liable to pay Cross-Subsidy Surcharge as determined by the Commission'. Manipur

Manipur Minor Mineral Concession (Second Amendment) Rules, 2022

The Manipur Government has issued Manipur Minor Mineral Concession (Second Amendment) Rules, 2022. By virtue of the Amendment, in Rule 39 which states condition of quarrying lease, it has been defined that only manual mining will be allowed in riverbed mining and no machinery shall be allowed. The depth of mining has been restricted to 3m/water level. It has also been provided that any breach of these conditions will lead to cancellation of lease.

Issuance of Industrial and Investment Promotion Policy of Manipur, 2022

The Manipur Government has issued Industrial and Investment Promotion Policy of Manipur, 2022. The policy is formulated with the objective of inviting investment in Manipur by private sector. The government will help in providing infrastructural support and incentives to industrial units identified under the policy. Some highlights of the policy are mentioned below:

- The policy shall be applicable to all micro, small and medium enterprises identified under thrust areas in the policy, which shall commence their commercial production in the state after March 21, 2023 till March 31, 2027.
- The State Government will encourage creation of supportive infrastructure like cold storage, packaging houses, warehouses, pre-cooling facilities etc.
- The State Government will also provide for trading with neighboring countries especially Myanmar and South-East Asian countries.

- The provisions of this policy will be applicable for a period of five years reckoned from the date of commercial production of the enterprise.
- The enterprise falling under the purview of this policy shall employ not less than 80% of its employee strength from local domiciled people of the state.
- The State will provide Capital Investment Subsidy at the rate 30% of their investment in plant and machinery subject to the aggregate ceiling of INR 50 lakh.
- The State will provide an interest subsidy of 3% on the working capital loan to all new industrial units for a period of ten years after the commencement of commercial production.
 The incentive will be disbursed to applicable enterprises in single instalment.

Manipur Mineral (First Amendment) Policy, 2022

<u>Extension of license period for sale of liquor under L-1/L-1F and L-2 (Draught Beer)</u> <u>License up to September 30, 2023</u>

However, any person holding such a non-renewable license shall not be under any obligation to accept such an offer to extend his license period.
