Securities and Exchange Board of India (SEBI)

 Audit of firm-level performance data of Portfolio Managers

SEBI on August 02, 2023 directed all Portfolio Managers to consider all clients' portfolios managed (i.e. clients of both discretionary and non-discretionary portfolio management services) for the purpose of audit of firm-level performance data. Furthermore, the Audit Report shall be submitted within 60 days from the end of each Financial Year.

 Corrigendum cum amendment to Circular dated July 31, 2023 on Online Resolution of Disputes in the Indian Securities Market

SEBI on August 04, 2023 directed all listed companies, specified intermediaries and regulated entities in the securities market (collectively referred to as Market Participant/s) shall enroll on the ODR Portal within specified timelines.

 Validity period of approval granted by SEBI to AIFs and VCFs for overseas investment

SEBI on August 04, 2023 reduced the time limit for making overseas investments by Alternative Investment Funds (AIFs)/Venture Capital Funds (VCFs) from 6 months to 4 months, so that the allocated limit is utilized efficiently and, if unutilized, the same is again available to the AIF industry in a shorter time span.

 Transactions in corporate bonds through RFQ platform by FPIs

SEBI on August 07, 2023 directed all Foreign Portfolio Investors to undertake at least 10% of their total secondary market trades in corporate bonds by value by placing/seeking quotes on the Request for Quote (RFQ) platform of stock exchanges, on a quarterly basis.

 Reduction of timeline for listing of shares in public issue from existing T+6 days to T+3 days

SEBI on August 09, 2023 reduced the time taken for listing of specified securities after the closure of public issue to 3 working days (T+3 days) as against the present requirement of 6 working days (T+6 days).

Timeline for the exit option window period for change in control of AMC

SEBI on August 11, 2023 provided the unitholders, an option to exit on the prevailing Net Asset Value (NAV) without any exit load within a time period not less than 15 calendar days from the date of communication. However, in case of change in control resulting in consolidation or merger of schemes, the unitholders are given an option to exit on the prevailing NAV without any exit load. Securities and Exchange Board of India (Foreign Portfolio Investors) (Second Amendment) Regulations, 2023

SEBI on August 10, 2023 amended Regulation 4 of Securities and Exchange Board of India (Foreign Portfolio Investors) Regulations, 2019. As per the amendment, the restriction of 25 % or more has been replaced with 'more than the threshold prescribed under sub-Rule (3) of Rule 9 of the Prevention of Money-laundering (Maintenance of Records) Rules, 2005'. This implies that FPIs need to comply with anti-money laundering rules for ownership and control identification.

Central Board of Direct Taxes (CBDT)

Income Tax (Fourteenth Amendment) Rules, 2023

CBDT on August 01, 2023 added Rule 6ABBB in the Income Tax Rules, 1962. The newly added Rule introduces Form No. 3AF for furnishing statements regarding preliminary expenses incurred by taxpayers. This form must be submitted one month prior to the due date for filing the income tax return. It should be furnished electronically either under digital signature or through an electronic verification code.

Income Tax (Fifteenth Amendment) Rules, 2023

CBDT on August 09, 2023 amended Rule 10TD - Safe Harbour, which provides list of eligible international transactions. The amendment provides that where an eligible assessee has entered into an eligible international transaction and the option for safe harbor is exercised, the transfer price declared by the assessee in respect of such transaction shall be accepted by the Income Tax authorities. This shall be applicable till end of Assessment Year 2022-2023.

Payment of TCS by e-commerce operators

The Ministry of Finance on August 04, 2023 directed all e-commerce operators to collect TCS for composition taxpayers, while unregistered individuals will require enrolment numbers before supplying goods. Furthermore, e-commerce operators must electronically provide details of goods supplied by composition taxpayers through Form GSTR-8 on the common GST portal.

Deferred Payment of Import Duty (Amendment) Rules, 2023

The Ministry of Finance on August 03, 2023 amended Rule 6 of the Deferred Payment of Import Duty Rules, 2016. As per the amendment, eligible importer shall be permitted to make the deferred payment if he has:

- Paid the duty for a bill of entry within due date.
- Paid the differential duty for the same bill of entry along with the interest on account of reassessment within 1 day (excluding holidays).

Amendment in Import Policy for computers and laptops

MCI on August 03, 2023 imposed restrictions on import of personal computers and other computer devices. The import of computer devices is now subject to the conditions specified in the Import Policy.

MCI on August 04, 2023 implemented Track and Trace system for export of drug formulations with respect to maintaining the parent-child relationship in packaging levels.

MCI on August 09, 2023 notified Fire Extinguishers (Quality Control) Order, 2023. As per the Order, portable fire extinguishers shall of Indian Standard 15683:2018 and wheeled fire extinguishers shall be of Indian Standard 16018:2012.

The Ministry of Civil Aviation on August 09, 2023 notified Aircraft (Security) Rules, 2023 to define the roles and responsibilities of Director General, Aircraft Security Committee and Private Security Agencies in providing security. The new Rules will supersede Aircraft (Security) Rules, 2011.

The Ministry of Communication on August 07, 2023 added Rule 9A in the Indian Telegraph Right of Way Rules, 2016. The newly added Rule 9A deals with establishment of temporary overground telegraph infrastructure in case of damage of any existing underground telegraph infrastructure for any reason.

The objective of the Act is to provide processing of digital personal data in a manner that recognizes both the right of individuals to protect their personal data and the need to process such personal data for lawful purposes and for matters connected therewith or incidental thereto. Andhra Pradesh

Andhra Pradesh Co-Operative Societies, 1964

The Government of Andhra Pradesh vide Notification dated August 09, 2023 amended the Andhra Pradesh Co-Operative Societies, 1964. The following amendments have been included:

- Rule 8(3) is substituted to provide that every notice under sub-Rule (2) shall be sent to the
 society's members and creditors by registered post or personal delivery or by its publication in
 a local leading newspaper (district edition) and also its publication on the notice board of the
 society, gram panchayat/Municipality, MPDO office and Tahsildar office.
- Rule 15 regarding restriction on holding shares is substituted to provide that where the liability
 of a member of a society is limited by shares, no member, other than a society or the
 Government, shall hold more than one-fifth of the share capital of the society. Provided
 further that in the case of a Cooperative Urban Bank, the individual shareholding of a member
 shall not exceed one-twentieth of the total paid share capital of the Bank.

Assam

Assam Motor Vehicle (Amendment) Rules, 2023

The Government of Assam vide Notification dated July 24, 2023 notified the Assam Motor Vehicle (Amendment) Rules, 2023 to amend the Assam Motor Vehicle Rules, 2003. Key aspects:

- In Rule 112, licenses shall be valid for 5 years and thereafter may be renewed for another 5 years on an application to the licensing Authority.
- In case of non-renewal of license in time, a fine of INR 50 per day shall be imposed.

Bihar

Amnesty scheme for tax defaulter transport and non-transport vehicle

The Government of Bihar on August 01, 2023 published a Notification regarding the amnesty scheme for tax defaulter transport and non-transport vehicle. As per the Notification, the State Government puts exemption from penalty/interest on depositing outstanding one-time toll tax/green tax by registered tax defaulter transport/non-transport vehicle/tractor-trailer/battery operated vehicle in the state of Bihar and all the above types of unrestricted vehicles on one-time deposit of outstanding road tax and one-time deposit of fees for temporary registration and due business tax by vehicle traders.

Chhattisgarh

Amendment in instructions regarding providing information on the portal

The Real Estate Regulatory Authority, Chhattisgarh on August 10, 2023 published a Notification amending the instructions issued earlier regarding providing information on the component-wise financial plan on the portal. As per the Notification, it was stated that the information of the component-wise financial plan of the project and additional disclosures to the promoters/developers should be compulsorily provided in the format attached with Circular number-83. Obligation to submit quarterly updates was abolished.

Exemption of registered persons from filing annual returns

The Office of the Commissioner of Commercial Taxes, Goa on August 10, 2023 issued a Notification exempting the registered person whose aggregate turnover in the Financial Year 2022-23 is up to INR 2 crore, from filing annual returns for the said Financial Year. The Notification shall come into force from July 31, 2023.

Gujarat

Notification to maintain public order, peace and security in the Rajkot rural, district area

The Government of Gujarat on August 09, 2023 published a Notification issuing orders to maintain public order, peace and security in the Rajkot rural district area to prevent any untoward incident during the month of August. The following acts are forbidden:

- Walking around with weapons, swords, spears, guns, knives, sticks or sticks, burning torches, other weapons capable of causing bodily injury
- Carrying any tubercular or explosive substance
- Carrying, collecting and preparing stones or other weapons or implements for throwing
- Showing persons or words or figures or effigies
- Making, displaying or disseminating any eloquent speech, aping or copying and preparing pictures, signs, public announcements, etc.

Haryana

Regulations for the use of DG sets in NCR districts of Haryana

The Government of Haryana on July 24, 2023 issued a Public Notice regarding Regulations for the use of DG sets in NCR districts of Haryana.

- The new regulations of DG sets would come into force in the entire NCR strictly w.e.f. October 01, 2023 and retro fitment of dual fuel kits or ECDs, wherever warranted, must be targeted to be completed latest by September 30, 2023 failing which the use of the diesel gensets shall not be permitted under any circumstances, anywhere in the entire NCR.
- All stakeholders using DG sets in the NCR have to comply with the Direction of CAQM well before September 30, 2023 failing which action will be taken as per law.

Aadhaar authentication services and eKYC authentication facility

The Government of Haryana on August 03, 2023 issued a Notification regarding notifies the use of Aadhaar authentication services, using Yes/No or/and eKYC authentication facility on a voluntary basis, for establishing the identities of individuals enrolled under various skill training schemes implemented by the Haryana Skill Development Mission, for the purpose of their attendance.

Himachal Pradesh Motor Vehicles (Amendment) Rules, 2023

The Government of Himachal Pradesh on August 01, 2023 notified the Himachal Pradesh Motor Vehicles (Amendment) Rules, 2023 to further amend the Himachal Pradesh Motor Vehicles Rules, 1999 whereby Rule 40 A, which talks about the Security and Fee for Authorization of Agency and issue of pollution under control certificate, has been amended. These rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

As per the Notification, the tax due by a dealer under Section 5 of Karnataka Sales Tax Act, 1957 on the sale of diesel up to 1,33,333 kilo liters for the period from August 1, 2023 is therefore free.

Lakshadweep

Draft Lakshadweep Excise Regulation, 2022

The Government of Lakshadweep on August 03, 2023 published the Draft Lakshadweep Excise Regulation, 2022. The following has been stated in the Draft:

- No person shall construct or establish any manufactory or warehouse or bottle, possess, sell, collect, transport, transit, import, export or purchase any liquor or use, keep or have in his possession any still, utensil, implement, apparatus, label, cork, capsule or seal for the manufacture of any liquor except under the authority and in accordance, with the terms and conditions of a letter of intent, license or permit granted under this of liquor.
- While considering an application for grant of a license or permit, the authorized officer shall ensure that the applicant:
 - Is a citizen of India.
 - Is above eighteen years of age.
 - o Is not a defaulter or blacklisted or debarred from holding an excise license.

Notification on Ayurvigyan Vishwavidyalaya (Sanshodhan) Adhiniyam, 2023

The Government of Madhya Pradesh on August 04, 2023 notified the Madhya Pradesh Ayurvigyan Vishwavidyalaya (Sanshodhan) Adhiniyam, 2023 further to amend the Madhya Pradesh Ayurvigyan Vishwavidyalaya Adhiniyam, 2011. The amendment is as follows:

- The Vice Chancellor shall be appointed by the Chancellor from a panel of not less than three persons recommended by the committee constituted.
- A person possessing the highest level of competence, integrity, the moral and institutional commitment shall be appointed as Vice-Chancellor.
- The person so appointed as Vice-Chancellor shall have at least 10 years of experience as a
 Professor in a Government College or University or shall be a distinguished academician with
 10 years of experience and demonstrated academic leadership in a reputed Government
 research or academic administrative organization at the national level.

Regulation on appropriate use of reverse osmosis based water purification system

The Maharashtra Pollution Control Board (MPCB) on August 01, 2023 notified regarding the regulation on appropriate use of reverse osmosis-based water purification systems in the States/UTs. The salient features of the Notification are as below:

- All Other than Domestic Water Purification System (ODWPS) are regulated within the provisions of Water (Prevention and Control of Pollution) Act, 1974 and rules made under the Environment (Protection) Act, 1986.
- Manufacturers and importers of ODWPS are required to register as per the provisions of the Plastic Waste Management Rules, 2016 and E-Waste (Management) Rules, 2016.
- Discarded elements from Domestic Water Purification System (DWPS) shall be managed as per the provisions of the Plastic Waste Management Rules, 2016, E- Waste (Management) Rules, 2016, Hazardous Waste Management Rules, 2016, as amended from time to time and plastic, electronic and electrical waste generated as discarded elements shall be brought under Extended Producer Responsibility (EPR).

Retrofitting of Emission Control Device (RECD) for in-use diesel operated internal combustion engines up to 800kW (1000KVA) gross mechanical power for generator set

The Maharashtra Pollution Control Board (MPCB) issued a Circular regarding the Retrofitting of Emission Control Device (RECD) for in-use diesel operated Internal combustion engines up to 800kW (1000KVA) gross mechanical power for generator set in the state of Maharashtra. The guideline provided Exhaust Emission Limits, Applicability and RECD to be installed on all the Phase-I & Phase-I engines/engine families as mentioned below, which have completed five years from the date/month of engine manufacturing:

- Phase-1 engines: The engines complying to emission limits as specified in CPCB Stage-1/GSR 371 dated May 17, 2002, and the diesel genset engines manufactured/imported on or after July 01, 2004, till July 01, 2014, shall establish the compliance of minimum 70% reduction of Particulate Matter by using the retrofitted after treatment device's without adversely affecting any other emission parameters.
- Phase-II engines: The engines complying to emission limits as specified in CPCB Stage-2/GSR 771(E) dated December 11, 2013, and its amendment vide GSR 232(E) dated March 31, 2014, and the diesel genset engines manufactured imported on or after July 01, 2014, shall establish the compliance of minimum 70% reduction of Particulate Matter by using the retro-fitted after treatment device/s without adversely affecting any other emission parameters.
- Within 120 days of the date that this Circular was issued, all projects, buildings, utilities, airports, train stations, and other locations in the State of Maharashtra that use diesel generator sets with a capacity of up to 800 KW (1000KVA) must comply with the said Circular.

Seeds (Maharashtra Amendment) Act, 2023

The Government of Maharashtra on August 04, 2023 notified the Seeds (Maharashtra Amendment) Act, 2023 further to amend the Seeds Act, 1966, in its application to the State of Maharashtra. In Section 19 of the Seeds Act, 1966, in its application to the State of Maharashtra (hereinafter referred to as the principal Act), Clauses (b) and (c) shall be deleted.

Notwithstanding anything contained in this Act or the Code of Criminal Procedure, 1973, the offences punishable under sub-Section (1) of Section 29, shall be cognizable and non-bailable.'

Kharif Marketing Season commences from October 01 each year or as per the dates notified by the Government of India.

The paddy arriving in the mandies shall be procured by the procurement agencies as per the specifications laid down by the Government of India. Paddy so procured shall be got milled from the rice millers of the state as per this policy. The State shall be taken as a single unit for the purpose of milling of paddy and delivery of rice.

The Notification stated that no tax is being deposited by the Rail Development Authority despite having tax liability after 30 years or more of land leased to the developers for commercial development.
