Goods and Service Tax Network (**GSTN**) on November 14, 2023 introduced an automated intimation on its portal (Form GST DRC-01C) for taxpayers to explain discrepancies in Input Tax Credit between GSTR-2B and GSTR-3B. If the claimed ITC exceeds a predefined limit, taxpayers receive an intimation. They must respond using Form DRC-01C Part B, detailing payment, or providing an explanation.

The Employees Provident Fund Organization (EPFO) on November 01, 2023 included two payment banks, namely Paytm Payments Bank Limited and Airtel Payments Bank Limited, In the second Schedule of Reserve Bank of India Act, 1934.

Employee State Insurance Corporation (ESIC) on November 8, 2023 instructed the employers to submit the records within 15 days of the show cause notice issued. The employer can file the contribution from the date of appointment.

Insurance Ombudsman (Amendment) Rules, 2023

The Central Government on November 9, 2023 added proviso to Rule 8 of the Insurance Ombudsman Rules, 2017, namely Insurance Ombudsman can resign by giving a written notice of at least 90 days, with the last day falling on the next working day if it's a Saturday, Sunday, or holiday.

Amendment to the Notification regrading activities when carried out in the course of business on behalf of or for another person

The Central Government issued an amendment to the Notification related to the 'activities when carried out in the course of business on behalf of or for another person' under Prevention of Money Laundering Act, 2002.

The following amendment has been stated: In the Notification number 2135 (E) dated May 9, 2023, in explanation 2, the following has been inserted: 'For the purposes of activities specified in this Notification, the Regulator within the meaning of Clause (fa) of sub-Rule (1) of Rule 2 of the Prevention of Money-laundering (Maintenance of Records) Rules, 2005, shall be the Director, Financial Intelligence Unit, India appointed under sub-Section (1) of Section 49 of the said Act'.

Food stuffs industry to be a public utility service

The Central Government has declared the services engaged in 'food stuffs' to be a public utility service for the purpose of the Industrial Disputes Act, 1947 for a period of 6 months from the date of publishing of the Notification i.e., November 9, 2023.

Lead and zinc industry to be a public utility service

The Central Government has declared the services engaged in 'lead and zinc mining industry' to be public utility service for the purpose of the Industrial Disputes Act, 1947 for a period of 6 months from the date of publishing of the Notification i.e., November 9, 2023.

Oil & gas

 <u>Suspension of approval process of CNG/CBG compressor package, used for filling of gas</u> cylinders and for dispensing as automotive fuel installed in the premises

The Petroleum and Safety Organization (PESO) on November 9, 2023 temporarily suspended the process of CNG/CBG compressor package, used for filling of gas cylinders and for dispensing as automotive fuel installed in the premises covered under license FORM E&F and G of the Gas Cylinder Rules, 2016, from obtaining approval from the O/o Chief Controller of Explosives, Nagpur up to July 31, 2024, subject to following conditions:

- All ex electrical components in the CNG/CBG compressor have approval of Chief Controller of Explosives
- An undertaking that all the electrical components installed in the CNG/CBG compressor are of the type approved by the Chief Controller of Explosives shall be submitted prior to grant/amendment (if applicable) of the license as well as during inspection of the premises

Processing or production or distribution of fuel gases (coal gas, natural gas and the like) to be public utility service

The Central Government has declared the services engaged in 'processing or production or distribution of fuel gases (coal gas, natural gas and the like)' to be a public utility service for the purpose of the Industrial Disputes Act, 1947 for a period of 6 months from the date of publishing of the Notification i.e., November 9, 2023.

Central Motor Vehicles (Ninth Amendment) Rules, 2023

The Central Government on November 6, 2023 added Rule 125M in the Central Motor Vehicles Rules, 1989. As per the new rule, approval of electric power train vehicles and hybrid electric vehicles must be taken, and the requirements shall meet the table specified under Rule 124.

Water Purification System (Regulation of Use) Rules, 2023

The Ministry of Environment, Forest and Climate Change on November 10, 2023 brought about new rules to regulate the use of domestic and commercial purification systems. These rules shall come into force on the expiry of 1 year from the date of their publication in the Official Gazette.

Punjab Liquor License (Chandigarh Second Amendment) Rules, 2023

The Government of Punjab issued the Punjab Liquor License (Chandigarh 2nd Amendment) Rules, 2023 to further amend the Punjab Liquor License Rules, 1956 whereby Rule 27, which specifies the procedure for grant of retail sale license of country liquor (I-14A) and Indian-Made Foreign Liquor (L-2), has been substituted.

Goa

Guidelines for OTS Scheme for Credit Societies 2023

The Government of Goa on November 02, 2023 issued a Notification regarding the Guidelines for the OTS Scheme for Credit Societies 2023. This scheme shall come into force on November 02, 2023. Key aspects:

- OTS Scheme shall apply to all the Primary Agricultural Credit/Multipurpose/Urban Cooperative Credit Societies registered in the State of Goa who are doing the credit and deposit business
- The Scheme shall not cover cases of fraud, misappropriation of funds, and wilful defaulter
- The benefits under the OTS Scheme shall be given to only those loan accounts wherein the society has made and accounted for adequate NPA provision in the audited balance sheet as of March 31, 2023
- Facilities/exemption in relation to any other loan repayment; they shall also not be eligible to avail of loan or stand surety to any type of loans advanced by the society for the next 6 years
- The last date of application to avail of the OTS shall be decided by the Board; however, the same shall not be extended beyond March 31, 2024 from the date of issue of revised Guidelines

Haryana

Draft of Haryana Solar Power Policy, 2023

The Government of Haryana on November 09, 2023 issued a Draft of Haryana Solar Power Policy, 2023 to supersede the Haryana Solar Power Policy, 2016, inviting suggestions and comments from the general public up to December 07, 2023.

Under the new Draft Haryana Solar Policy 2023, the state has set an ambitious target to install a cumulative 6 GW of solar capacity by 2023. This includes 1.6 GW of rooftop solar power plants, 3.2 GW of ground-mounted solar power plants (with or without energy storage), and the solarization of irrigation pumps with a capacity of 1.2 GW.

Electronic commerce operator who is required to collect tax at source under Section 52

The Government of Haryana on October 27, 2023 issued a Notification regarding electronic commerce operators who are required to collect tax at source under Section 52.

- The electronic commerce operator shall allow the supply of goods through it by the said person only if an enrolment number has been allotted on the common portal to the said person
- The electronic commerce operator shall not allow any inter-state supply of goods through it by the said person
- The electronic commerce operator shall not collect tax at source under sub-Section (1) of Section 52 in respect of the supply of goods made through it by the said person
- The electronic commerce operator shall furnish the details of supplies of goods made through it by the said person in the statement in FORM GSTR-8 electronically on the common portal

Amendment to the Notification related to the special procedure to be followed by a registered person engaged in manufacturing of goods

The Government of Haryana issued an amendment to the Notification related to the special procedure to be followed by a registered person engaged in manufacturing of goods.

As per the amendment, in Notification No. 44/GST-2, dated August 29, 2023, after the words 'hereby notifies the following special procedure to be followed', the words and figures 'with effect from 1st day of January 2024' have been inserted and shall be deemed to have been inserted with effect from August 29, 2023.

Special Road Tax for motor vehicles registered in the state

The Government of Himachal Pradesh on November 01, 2023 issued a Notification pertaining to Special Road Tax (SRT) on motor vehicles registered in the state. The SRT shall be levied, charged and paid to the State Government on the Transport Vehicles defined in the Notification used or kept for use in Himachal Pradesh with the respective rates.

- Rule 7 which states 'Issue of pass for export or transport of forest produce' has been substituted

<u>Jharkhand State Electricity Regulatory Commission (Terms and Conditions for</u> Determination of Generation Tariff) (First Amendment) Regulations, 2023

The Jharkhand State Electricity Regulatory amended the Jharkhand State Electricity Regulatory Commission (Terms and Conditions for Determination of Generation Tariff) Regulations, 2020. These Regulations shall not apply to the following cases:

- Generating Stations whose tariff has been discovered through tariff-based competitive bidding in accordance with the guidelines issued by the Central Government and adopted by the Commission under Section 63 of the Act
- Generating Stations based on renewable sources of energy

Maharashtra Municipal Corporations (Transfer of Immovable Property by Lease and Renewal of Lease) Rules, 2023

The Government of Maharashtra on November 06, 2023 replaced the Maharashtra Municipal Corporations (Renewal of Lease or Transfer of Immovable Property) Rules, 2019. These Rules are applicable for the transfer of immovable property of the Municipal Corporation by lease, renewal of lease, or sub-lease thereof to the third party, with the approval of the Corporation.

Manipur

Manipur Shops and Establishments (Regulation of Employment and Conditions of Service) Act, 2021

The Government of Manipur on November 06, 2023 published the Manipur Shops and Establishments (Regulation of Employment and Conditions of Service) Act, 2021 to consolidate the laws relating to the Regulation of Employment and other Conditions of Service of workers employed in shops and establishments. The said Amendment Act shall come into force with effect from June 29, 2021. The Act shall apply to all shops and establishments employing 10 or more workers except the following:

- Worker occupying the position of confidential, managerial, or supervisory nature in a shop or establishment
- Worker whose work is inherently intermittent
- Any shop or establishment run by the Union State government or local authority
- Any officer of the Reserve Bank of India
- A member of the family of any employer
- An establishment used for the treatment or care of the sick, infirm, destitute, or mentally unfit

The existing Manipur S&E Act, 1972 and the Manipur S&E (Regulation of Employment and

Conditions of Service) Ordinance, 2021 are hereby repealed.

NCT of Delhi

Implementation of actions under Stage-IV ('severe+' air quality) of the revised GRAP in Delhi-NCR

The Commission for Air Quality Management in National Capital Region and Adjoining Areas (CAQM) on November 05, 2023 issued an order regarding the implementation of actions under Stage-IV ('severe+' air quality) of the revised Graded Response Action Plan (GRAP) in Delhi-NCR.

Currently, all actions up to Stage-III of the GRAP are already in force in NCR w.e.f. November 02, 2023. The sub-Committee has decided to take the following actions:

- Stop entry of truck traffic into Delhi (except for trucks carrying essential commodities/providing essential services and all LNG/CNG/electric trucks
- Prohibit LCVs registered outside Delhi, other than EVs/CNG/BS-VI diesel, to enter Delhi, except those carrying essential commodities/providing essential services
- Ban on plying of Delhi registered diesel operated Medium Goods Vehicles (MGVs) and Heavy Goods Vehicles (HGVs) in Delhi, except those carrying essential commodities/providing essential services
- Ban C&D activities also in linear public projects such as highways, roads, flyovers, overbridges, power transmission, pipelines etc.
- NCR State Govts and GNCTD may take a decision on discontinuing physical classes even for classes VI–IX, and class XI and conduct lessons in an online mode
- NCR State Governments/GNCTD to take a decision on allowing public, municipal and private
 offices to work on 50% strength and the rest to work from home
- The Central Government may make appropriate decisions on permitting work from home for employees in central government offices

 State Governments may consider additional emergency measures like the closure of colleges/educational institutions and closure of non-emergency commercial activities, permitting the running of vehicles on an odd-even basis of registration numbers, etc.

Non-issuance of P10 permits to independent restaurants for hosting functions

The Government of NCT of Delhi on November 01, 2023 issued a Circular regarding non-issuance of P10 permits to independent restaurants for hosting functions whereby the Circular states that many independent restaurants are hosting functions on P-10 permits, despite Excise Department already debarring such restaurants for hosting functions using the said permits. Therefore, all L-6 retail vends have been directed to ensure that no P-10 permits shall be issued to Independent Restaurants for hosting functions.

Furthermore, a list of HCR Licensees and a list of all Eating Houses eligible for the Excise License have been provided in the said Circular. Non-Compliance may lead to cancellation of licenses against the defaulter L-6 vends.
