# Securities and Exchange Board of India (SEBI)

 Intermediaries registered with SEBI under Section 12 of the Securities and Exchange Board of India Act, 1992

SEBI on February 20, 2024 directed all intermediaries to upload FATCA and CRS certifications obtained from clients on to the system of KRAs with effect from July 01, 2024.

# Reserve Bank of India (RBI)

Interest Equalization Scheme (IES) on Pre and Post
 Shipment Rupee Export Credit

RBI on February 22, 2024 allowed for extension of the Interest Equalization Scheme for Pre and Post Shipment Rupee Export Credit (**Scheme**) up to June 30, 2024. The rate of interest equalization shall be 2% for manufacturers and merchant exporters exporting under specified 410 HS lines and 3% for MSME manufacturers exporting under any HS line.

RBI on February 27, 2024 notified Master Direction - Reserve Bank of India (Filing of Supervisory Returns) Directions - 2024. These Master Directions are applicable to:

- All Commercial Banks excluding RRBs
- All Primary (Urban) Co-operative Banks
- All India Financial Institutions (Exim Bank, NABARD, NHB, SIDBI and NABFID)
- All Non-Banking Financial Companies [excluding Housing Finance Companies (HFCs)] and all Asset Reconstruction Companies (ARCs)

# **Ministry of Corporate Affairs (MCA)**

Companies (Registration Offices and Fees) Amendment Rules, 2024

The Ministry of Corporate Affairs on February 15, 2024 added Rule 10A in Companies (Registration Offices and Fees) Rules, 2014. As per the amendment:

- The Registrar of the Central Processing Center shall examine or cause to be examined every application or e-form or document required or authorized to be filed or delivered, as provided under sub-Rule (3), for approval, registration or taking on record by the Registrar.
- The Registrar shall take a decision on the application, e-forms or documents within thirty days from the date of its filing excluding the cases in which an approval of the Central Government or the Regional Director or any other competent authority is required.

If the District Medical Board certifies that either spouse needs donor gametes for surrogacy, it's permitted, but the child must have at least one gamete from the intending couple.

# Motor Vehicles (DRAFT Amendment) Rules, 2024

The Ministry of Road Transport and Highways on February 22, 2024 amended Rule 115 of Central Motor Vehicles Rules, 1989. As per the amendment, type approval for vehicles retrofitted with LPG kits shall be valid for 6 years from the date of issue of such approval and shall be renewed for every 6 years at a time. # Electricity (Rights of Consumers) Amendment Rules

The Ministry of Power on February 22, 2024 amended Electricity (Rights of Consumers) Rules, 2020. The major amendments made are as follows:

- Facilitating easier and faster installation of rooftop solar systems
- Separate connections for electric vehicle charging stations
- New connections and change in existing connections to be obtained faster
- Additional rights for consumers in residential colonies and flats
- Mandatory additional meter in cases of complaints

### **Andhra Pradesh**

# APERC (The Grid Interactive Solar Rooftop Photovoltaic Systems under Net/Gross Metering) Regulation, 2023

The Andhra Pradesh Electricity Regulatory Commission (APERC) on February 23, 2024 issued the Andhra Pradesh State Electricity Regulatory Commission (The Grid Interactive Solar Rooftop Photovoltaic Systems under Net/Gross Metering) Regulation, 2023. These regulations apply to all the grid-interactive solar rooftop photovoltaic systems with/without Battery Energy Storage Systems (BESS), installed, and commissioned in the areas of Distribution Licensees. The consumer is eligible to install the grid interactive SRTPVS of the rated capacity as specified under these Regulations, a minimum vacant roof area of 10 sq mtr or 100 sq. ft is required for the installation of 1 KWp system. This shall come into force on February 23, 2024.

# Suspension of certain provisions of the Shops & Establishment Act, 1971

The Government of Assam issued a Notification to suspend the operation of Sections 6, 9, 10 and 11 of the Shops & Establishment Act, 1971 throughout the State of Assam during certain festivals for 70 days i.e. on the occasions as mentioned in the table during the year 2024. The shops and establishments will remain open for 70 days subject to the condition that the employees shall be paid compensation for overtime work and for work on weekly off days by the employers concerned. # Revised VDA rates for workmen employed by contractors in Assam

The Labour Commissioner of Assam issued a Notification dated February 08, 2024, addressing the revision of Variable Dearness Allowance (VDA) rates for workmen employed by and through contractors, not covered under the Minimum Wages Act, 1948. The VDA rates are adjusted based on the increase in the Consumer Price Index (CPI) from July 2023 to December 2023, which is calculated at 2.69%. The Notification outlines the new VDA rates for different categories of workmen, including highly skilled/accountants, skilled (ITI Certificate holders or equivalent/clerical), skilled (other than ITI Certificate holders), semi-skilled, and unskilled workmen. The new rates, are provided in a detailed table, specifying the basic rated amounts, cumulative existing VDA rates, percentage increase, and the new rates per day and per month.

# Goa Motor Vehicles Tax (Amendment) Bill, 2024

The Government of Goa issued a Bill on February 16, 2024 pertaining to the 'Goa Motor Vehicles Tax (Amendment) Bill, 2024,' which aims to amend the Goa Motor Vehicles Tax Act, 1974. The Bill encompasses several key amendments, including the introduction of new tax rates for various categories of motor vehicles at the time of registration, simplification of the tax structure, and the repeal of the Goa Motor Vehicles Tax (Amendment) Ordinance, 2023. The new tax rates are categorized based on the cost of the vehicle, such as 9%, 12%, and 15% tax on the invoice value at the time of registration for vehicles falling within specific cost brackets. Additionally, the Bill proposes a one-time payment of tax on the registration of rent-a-cars and rent-a-bikes, as opposed to the existing yearly tax payment structure.

# Goa Land Use (Regulation) (Amendment) Bill, 2024

The Government of Goa on 16th February, 2024 introduced the Goa Land Use (Regulation) (Amendment) Bill, 2024. This Bill is aimed at amending the Goa Land Use (Regulation) Act, 1991. The amended section specifies exemptions including the acquisition of land vested in a tenant under the Goa Agricultural Tenancy Act, 1964, by the State for public purposes under the Land Acquisition Act, 1894, and the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

### Goa Labour Welfare Fund (Amendment) Bill, 2024

The Government of Goa on February 16, 2024 issued the Goa Labour Welfare Fund (Amendment) Bill, 2024 to further amend the Goa Labour Welfare Fund Act, 1986. In Section 20, which pertains to appointment and power of Secretary, for sub-Section (1), the following sub-Section has been substituted: '(1) The Government shall appoint the Commissioner, Labour and Employment as Secretary of the Board, who shall be the Chief Executive Officer of the Board.'

### Goa Buildings (Lease, Rent and Eviction) Control (Amendment) Bill, 2024

The Government of Goa issued a bill on 05th February 2024, known as The Goa Buildings (Lease, Rent and Eviction) Control (Amendment) Bill, 2024. The Bill is aimed at amending the Goa Buildings (Lease, Rent and Eviction) Control Act, 1968. The amendments proposed include:

- Insertion of new clauses related to 'agreement of leave and license,' 'Deputy Collector,' 'leave and license,' and 'licensee,'
- Substitution concerning the landlord's right to obtain possession
- A new provision is to be added, dealing with the resumption of occupation of the building given on leave and license basis

With the substitution of '192 days' for '90 days,' this legislative initiative aims to streamline tax compliance procedures and enhance regulatory efficiency in the state. # Gujarat Electricity Regulatory Commission (Terms and Conditions for Green Energy Open Access) Regulations, 2024

# Haryana

### Haryana Green Hydrogen Policy 2024

The Haryana Green Hydrogen Policy 2024 positions the state as a frontrunner in the burgeoning green hydrogen sector, aiming to produce 250 kilo tons per annum (KTPA) of Green Hydrogen by 2030. This initiative aligns with the National Green Hydrogen Mission and focuses on accelerating the adoption of green hydrogen and its derivatives to reduce dependence on fossil fuels, enhance energy security, and promote sustainable development. This Notification was published on February 15, 2024. Under this Policy, eligible projects can benefit from various incentives and subsidies, particularly those procuring renewable energy from multiple sources including third-party procurement, captive plants, distribution licensees, and power exchanges. Additionally, the Policy emphasizes the importance of research and development, job creation, and reducing emissions from activities like crop burning by utilizing biomass for green hydrogen production.

# Revision to minimum wages

# Key aspects:

- Determination of Baseline: The baseline values (operating and cost parameters) for the base year of the control period shall be determined by the Commission and shall be based on the approved values by the Commission, the latest audited accounts, the estimate of the actuals for the relevant year, prudence check and other factors considered appropriate by the Commission. The Commission may re-determine the baseline values for the base year based on the actual audited accounts of the base year.
- Segregation of Accounts: The hydro-generating company shall maintain separate accounts and sub-balance sheets for each of its power plants.

- To rationalize the number of taxes/duties and other levies to optimize revenues for the common good
- To check bootlegging/smuggling of liquor and narcotic drugs in the Union Territory of Jammu and Kashmir from neighboring States/Union Territories
- To provide the choice of liquor brands and places for consumption to its consumers and a level playing field to all the stakeholders
- To rationalize the production and sale of JK Special Whisky and JK Country Liquor to curb illicit distillation
- Tapping of the full potential of the existing liquor Industry to promote ancillary industries and raising new avenues of employment
- Complete digitalization in liquor manufacturing, distribution and sale from production till retail consumption

- 2nd Proviso to Regulation 4.15 which states 'Charges for Stand-by support' has been substituted

# <u>Draft Madhya Pradesh Electricity Regulatory Commission (Fees, Fines and Charges)</u> (Revision-II) Regulations, 2024

- The fines and/or charges as ordered by the Commission shall be paid within 30 days of the order of the Commission imposing the fines or charges or within such extended date as may be allowed by the Commission in such order.
- The fines and/or charges shall be payable in the same manner as provided under sub-Clause
   (ii) of Clause 3 of these Regulations.
- If the fines and/or charges ordered by the Commission are not paid within the specified time, they shall be recoverable as arrears of land revenue.

- Applications already pending with the Board that have not paid the Penal Fees will also be considered, provided they pay the penal fees as per the Amnesty Scheme within 3-month period from March 01, 2024 to May 31, 2024.

- The DG set 125 KW to less than 800 KW is now amended to 61 KW to 800 KW
- The DG set 19 KW to less than 125 KW is now amended to 19 KW to 61 KW

It also addresses the consequences if the clearance is not granted within the stipulated period, including the payment of interest by the distribution licensee to the applicant.
- Another significant amendment introduces separate queues for maintaining seniority in respect of applications for different categories of supply connections, based on the requirement for augmentation or extension of distribution infrastructure. The Notification also details amendments and introduces provisions regarding the deposit of applicable charges and the processing of cases where consumers fail to comply with the demand notice.
