Ministry of Agriculture

Fertilizer (Inorganic, Organic or Mixed) (Control)(Third) Amendment Order, 2024

The Ministry of Agriculture and Farmers Welfare on May 08, 2024, amended Fertilizer (Inorganic, Organic or Mixed) (Control) Order, 1985. The amendment order specifically focuses on biostimulants. The amendment states that biostimulant specifications shall include tracer molecules in addition to active ingredients. The order also introduces 'live micro-organisms excluding biofertilizers and biopesticides' as an additional category of biostimulants specified under Schedule VI.

Andhra Pradesh

Andhra Pradesh Electricity Regulatory Commission (Green Energy Open Access, Charges, and Banking) Regulation, 2024

The Andhra Pradesh Electricity Regulatory Commission (APERC) on May 02, 2024, notified the Andhra Pradesh Electricity Regulatory Commission (Green Energy Open Access, Charges, and Banking) Regulation, 2024.

This Regulation shall be applicable for allowing Open Access to electricity generated from Renewable Energy Sources, for use of Intra-State Transmission System's (InSTS) and/or distribution system's of licensee's in the State, including such Intra-State Transmission and/or distribution system's, which are incidental to Inter-State Transmission of electricity.

This Regulation supersedes all the earlier Regulations/Stipulations/Guidelines/ Directions issued by the Commission in the matter of Open Access to Green Energy.

Bihar

Aadhaar Authentication under the e-Shikshakosh portal

The Education Department, Bihar on May 07, 2024, issued a notification regarding Aadhaar Authentication under the eShikshakosh portal.

As per the Notification, the Department of Education will perform Aadhaar Authentication, voluntarily, for the Authentication of students enrolled in schools of Bihar under the e-Shikshakosh portal using the Yes/No or/and e-KYC authentication facility.

Goa

Revised state action plan for control of noise pollution

The Environment & Climate Change department of Goa notified regarding the revised State Action Plan for Control of Noise Pollution in supersession of the previously released Notification dated March 14, 2024, related to State Action Plan for Control of Noise Pollution. It states that:

- Functions/events with fewer than 100 attendees, private functions at residential premises, and community religious functions shall be exempted from permission requirements and open-air permanent venues can secure permission for up to 3 years, while temporary venues shall obtain permission for each event.
- Owners of permanent open-air venues in Goa shall submit an application to the Director of Environment & Climate Change, along with location details and an annual fee of Rs. 60,000, to use loudspeakers or sound amplifiers.
- There shall be no application fee for events proposed to be conducted by Government, religious institutions, and sports events and for religious, and traditional cultural functions.
- Authority shall levy compensation for Noise Rule violations based on reports or complaints of an officer in-charge of a police station, to prevent public annoyance, discomfort, disturbance, or injury

Govt of NCT of Delhi

Prevention of heat wave in all the establishments/factories/shops/construction sites in Delhi

The Labour Department, Government of the National Capital Territory of Delhi (GNCTD) on May 08, 2024, issued a circular regarding preventing heat waves in all the establishments/factories/shops/ construction sites in Delhi.

- Ensure adequate clean drinking water availability at the workplace.
- Ensure availability of cooler/fans at the workplace.
- Sensitizing/imparting training to the workers/employees about the precautions to be taken during heat wave conditions including covering their heads during direct exposure to sunlight etc.
- Make emergency kits (Ice packs, ORS, etc.) for the construction workers/employees.
- Change the shift of work as far as possible, to avoid peak hours (12-4 PM)
- Report any case of heat-related illness to a nearby health facility/hospital

Guidelines for handling end of life vehicles in public places of Delhi, 2024

The Transport Department, NCT of Delhi issued the guidelines for handling end-of-life vehicles in public places in Delhi, 2024.

- These Guidelines shall be applicable in the NCT of Delhi
- These guidelines were created for effective implementation of various directions of the National Green Tribunal and for improvement of air quality in Delhi.

The guidelines have come into force on February 22, 2023.

Portal to facilitate licensing, payment of fees, and ensuring other compliances

The Transport Department, Government of the National Capital Territory of Delhi (GNCTD) notified regarding the portal to facilitate licensing, payment of fees, and ensuring other compliances.

- All eligible aggregators, delivery service providers and ecommerce entities must register on the portal to obtain the required license, followed by credentials to start on-boarding of the vehicle as per policy notified. It can be accessed at https://www.myfleet.delhi.gov.in/
- All license holders are requested to register their existing fleets operating in the NCT of Delhi.
- All existing Aggregator and Delivery Service Providers operating within the NCT of Delhi shall obtain a license within a period of 90 days from the date of publication of this public notice.

Himachal Pradesh

Processing/administrative charges for the grant of EC to the project proponents for Category-'B' projects

The Government of Himachal Pradesh issued the processing/administrative charges for the grant and Renewal of EC to the Project Proponents for Category-'B' projects (Mining & Other Projects).

The State Level Environment Impact Assessment Authority (SEIAA), Himachal Pradesh has been constituted by MoEF&CC, GoI in pursuance to EIA Notification, 2006 for granting Environmental Clearance (EC) to the Category 'B' Projects in Himachal Pradesh.

- The processing/administrative charges are excluding expenses to be incurred by the Project Proponents for advertising Public Hearing Notification in one major National Daily and one Regional Daily News Paper and expenses for arranging public hearing in the case of Category-B Projects. The Project Proponent shall also remit the Processing Charges of INR 5,000 only while seeking the Transfer of Environmental Clearance.
- 50% of the total amount received by the SEIAA through processing/administrative charges shall be deposited in the Government Treasury under relevant receipt head.

Meghalaya

Prohibition on the use of streams or wells for disposal of polluting matter, etc. along the catchment/tributaries of the Umiew River

The Meghalaya State Pollution Control Board on May 01, 2024, issued an order to prohibit the use of streams or wells for disposal of polluting matter, etc. along the catchment/tributaries of Umiew River etc.

- Section 24 1(a) of the Water (Prevention and Control of Pollution) Act, 1974 prohibits on use of streams or well for disposal of polluting matter, etc. subject to the provision of this section that no person shall knowingly cause or permit any poisonous, noxious or polluting matter determined under such standards as may be laid down by the State Board to enter (whether directly or indirectly) into any 3 [stream or well or sewer or on land);
- Section 24 1(b) of the Water (Prevention and Control of Pollution) Act, 1974 prohibits the use of streams or wells for disposal of polluting matter, etc. subject to the provision of this section that no person shall knowingly cause or permit to enter into any stream any other matter which may tend, either directly or in combination with similar matters, to impede the proper flow of the water of the stream in a manner leading or likely to lead to a substantial aggravation of pollution due to other causes or of its consequences
- Section 43 of the Water (Prevention and Control of Pollution) Act, 1974 penalty for contravention of provisions of section 24 that whoever contravenes the provisions of section 24 shall be punishable with imprisonment for a term which shall not be less than (one year and six months) but which may extend to six years and with fine.

Puducherry

Launch of online service for the amendment of Registration Certificate

The Labour Department, Puducherry on April 23, 2024, issued the notification regarding the launch of online service for the amendment of the Registration Certificate under the Building and Other Construction Workers Act through the Government of India web-based application Service Plus portal.

Applications in respect to the Amendment of Registration Certificate under the Building and Other Construction Workers Act shall be received and granting of amended RC under Building and Other Construction Workers Act shall be done only online through Service Plus portal.

Paid holiday on poll day for the Migrant Employees

The Government of Puducherry on April 25, 2024, declared a paid holiday on poll day for the Migrant Employees.

It is instructed that the employers of all shops and other establishments located in the entire Union Territory of Puducherry shall grant paid holiday on the polling day to their migrant employees corresponding to the day of the poll for a particular migrant employed by them.

Rajasthan

Exemption of registered shops and commercial establishments from certain provisions of the Rajasthan Shops and Commercial Establishments Act, 1958

The Government of Rajasthan on May 02, 2024 issued a notification regarding the exemption of registered shops and commercial establishments from certain provisions of the Rajasthan Shops and Commercial Establishments Act, 1958. The shops and commercial establishments registered under the Rajasthan Shops and Commercial Establishments Act, 1958 will be exempted from the provisions of Section 12(1) of the Act (keeping shops and commercial establishments closed for 1 day in a week) for a period of 3 years subject to the following conditions: -

- All employed employees will be given paid weekly holiday by the employer 1 day a week, on a rotation basis.
- The working hours of the employed employees will be 48 hours weekly. If more work is
 required from the employees than the stipulated working time period, then its record will be
 maintained separately.
- Payment of wages to every employed employee for overtime work will be per the Act.
- All employed employees will be given appointment letters by the employer.

Minimum Wage Revision

The State Government, in accordance with the Minimum Wages Act of 1948, has issued a notification updating the minimum wages and variable dearness allowance across various industries. These industries include stone breaking, glass and chinaware, salt production, woolen carpet making, dushale weaving institutes, and papad production. The variable dearness allowance is determined based on the Consumer Price Index of Industrial Workers 2003 (with a base of 1960–100) and is adjusted annually. The latest adjustment, effective from October 1, 2023, to September 30, 2024, indicates a 300-point increase in the index compared to the previous period. This adjustment complements the revised minimum wage set by the state government.

Sikkim

Notice to all PIBOs and Plastic Waste Processors to register in the centralized EPR portal

The State Pollution Control Board-Sikkim (SPCB-Sikkim) issued a Notice to all Producers, Importers & Brand-Owners (PIBOs) and Plastic Waste Processors to register in the centralized EPR portal. The following has been stated:

- It has earlier instructed all Producers, Importers & Brand Owners including Plastic Waste Processors (Recyclers, Coprocessor, Waste to Energy, Waste to Oil, and Industrial Composting) to register in the portal by March 31, 2024 failing which legal action is to be initiated by the Board.
- All industries operating in the state are hereby given final notice to comply with the direction at the earliest

Tamil Nadu

Increase in price of liquor from February 2024

The Government of Tamil Nadu issued a notification to Increase the price of liquor from February 01, 2024.

Excise Duty on Liquor has been hiked and accordingly, the price of Liquor has been hiked with effect from February 01, 2024.

- The price of regular and medium-sized liquor has been hiked by INR 10/-.
- The price of high-quality alcoholic beverages has been increased by INR 20/-.
- The price of the full range of beer has been increased by INR 10/-.

Telangana

Revised Variable Dearness Allowance

The Commissioner of Labour, Telangana has released the latest average State Industrial Workers Consumer Price Index Numbers.

These figures, effective from April 01, 2024 to September 30, 2024, serve as the basis for computing Variable Dearness Allowance in various Scheduled Employments across Telangana.

- Part-I highlights an 81-point surge from 1768 to in the Industrial Workers category
- Part-II notes a 75-point rise from 1346 to for Agricultural Workers

Declaration of holiday due to the election poll

The Government of Telangana on May 02, 2024, issued a notification regarding a holiday due to the election poll.

The authorities mentioned are notified regarding the declaration made by the Government of Telangana, granting a paid holiday on May 13, 2024 (Monday) for all employees and workers in Factories, Shops & Establishments, and Industrial Undertakings/Establishments, on the day of polling.

The holiday on polling day applies only to Industrial Undertakings / Establishments working on a shift basis, specifically for the shift during which the poll is conducted (from 7.00 AM to 6.00 PM). This measure aims to facilitate employees' participation in the General Elections to Lok Sabha, 2024, and the Bye-Election to 71-Secunderabad Cantonment (SC) Assembly Constituency.

Deletion of the provision of registration of shop or establishment under the Tripura Shops and Establishments Act, 1970

The Government of Tripura notified that no shopkeeper or employer is required to apply for registration of his shop or establishment under the Tripura Shops and Establishments Act, 1970.

The State Government has deleted Section 16 of The Tripura Shops and Establishments Act, 1970 vide The Tripura Shops and Establishments (Fifth Amendment) Act, 2021 to comply with the purpose of Ease of doing Business in the State.

The Tax Department, West Bengal vide Notification dated May 14, 2024, extended the last date for online filing of profession Tax return for the Financial Year of 2023-24 in Form III till May 31, 2024, and the last date for the submission of paper copy has been extended to June 15, 2024.
