- One plate of meat/chicken curry should have 200 grams net meat pieces *i.e.* atleast minimum 5 pieces and 100 grams of gravy.

2. Matar Paneer, Palak Paneer etc. must have atleast 100 grams cheese.
3. In the packed commodities *i.e.* bread / milk etc., the price, date of packing should be as W & M Commodities Package Act, 1976.
4. Every dealer/ shopkeeper shall display the price list of these commodities at the entrance of the business premises, which should be duly signed by the owner/manager.
5. On the demand of the customer, every shopkeeper shall issue cash memo/bill to the customer.

This notification shall be valid for a period of one month from the date of publication in the Official Gazette.
