**ORDER:**

In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (Central Act 10 of 1955) the Central Government have amended Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs Amendment Order, 2016 and as per the Gazette of India, 4<sup>th</sup> read above, Government hereby modify the orders were issued vide 2<sup>nd</sup> read above with revised stock limits in respect of Traders/Wholesaler, Retailer, Big Chain Retailer, Processors of Wheat upto 31<sup>st</sup> March, 2025 in the State of Telangana.

Further, Government hereby order that "Respective legal entities, as above, shall declare the stocks position on the portal (<http://evegoils.nic.in/wsp/login>) of Department of Food and Public Distribution and in case the stocks held by them are higher than the prescribed limits, then they shall bring the same to the prescribed stock limits within 30 days of issue of GoI notification and the stock is regularly declared and updated on the portal Department of Food & Public Distribution (<http://evegoils.nic.in/wsp/login>)."

3. The Commissioner of Civil Supplies, Telangana, Hyderabad is directed to issue necessary instructions to all the concerned to enforce the above orders and shall take necessary further action, accordingly.
