In exercise of the powers conferred by sub section (1) of section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957), the Government of Kerala hereby make the following rules further to amend the Kerala Minor Mineral Concession Rules, 2015 issued by notification under G. O. (P) No.16/2015/ID. dated 7<sup>th</sup> February, 2015 and published as S.R.O. No. 72/2015 in the Kerala Gazette Extraordinary No. 288 dated 7<sup>th</sup> February, 2015, namely:-



## RULES

1. *Short title and commencement.*-(1) These Rules may be called the Kerala Minor Mineral Concession (Amendment) Rules, 2026.

(2) They shall come into force at once.

2. *Amendment of the Rules.*- In the Kerala Minor Mineral Concession Rules, 2015,-

(1) in rule 4, in sub rule (2), in clause (d), for the figure "1904", the figure and symbol "1908" shall be substituted.;

(2) in rule 5, in sub-rule (1),- (i) for the words "one thousand", the words "five thousand" shall be substituted.;

(ii) the following proviso shall be inserted, namely:-

"Provided that in case of prospecting license for dimension stones, the application shall be accompanied by a fee of two thousand rupees.";

(3) in rule 14,-(i) in sub-rules (6), (7) and (10) for the words "one year" the words "two years" shall be substituted.;

(ii) after sub-rule (12), the following sub-rule shall be inserted, namely:-

"(13) In cases and classes of cases, where an area permitted to extract ordinary earth has met with any other minor mineral while progressing the extraction, the competent authority shall issue movement permit for the removal of newly obtained minor mineral, where the volume of minor mineral to be removed shall not exceed the difference between the volume permitted in the building plan and the volume of ordinary earth removed. In such case, the applicant has to remit in advance the royalty for the entire remaining quantity of the new mineral in addition to the royalty already paid for ordinary earth.";

(4) In Rule 27, in sub-rule (2), in clause (c), for the figure "1904", the symbol and figure, "1908" shall be substituted.;

(5) in rule 28,-(i) in sub-rule (1), for the symbol, figure, bracket and words "₹10,000 (Rupees Ten Thousand only)", the words "twenty thousand rupees" shall be substituted.;

(ii) in sub-rule (2) for the words "twenty thousand", the words "forty thousand" shall be substituted.;

(6) rule 47 shall be omitted;

(7) In rule 55, after the word "approval" the words, symbol and bracket "along with an application and a chalan receipt of rupees twenty five thousand remitted to the Government



treasuries to the credit of the Department of Mining and Geology under the relevant receipt head of account towards application fee, except for the quarrying permit for Laterite (building stone)" shall be inserted;

(8) in rule 57, the following proviso shall be inserted, namely:-

"Provided that in the case of submission of quarry closure plan, the application shall be accompanied by a chalan receipt of rupees twenty five thousand remitted to the Government treasuries to the credit of the Department of Mining and Geology under the relevant receipt head of account towards application fee, except for the quarrying permit for Laterite (building stone).";

(9) in rule 67, after sub-rule (6), following sub-rule shall be inserted, namely:-

"(7) Every application for the approval of scheme of mining shall be accompanied by a chalan receipt of rupees twenty five thousand remitted to the Government treasuries to the credit of the Department of Mining and Geology under the relevant receipt head of account towards application fee, except for the quarrying permit for Laterite (building stone).";

(10) in rule 72,-

(i) after sub-rule (1), the following proviso shall be inserted, namely:-

"Provided that in such case the lessee shall submit an application in Form V along with all relevant documents as appended in said Form. The lessee shall execute a deed in this regard in Form W after obtaining permission in writing from the competent authority.";

(ii) in sub-rule (2), after the words "total production since opening", the symbol and words, ",report regarding payment of all outstanding dues to the Government issued by the competent authority" shall be inserted;

(11) in rule 98, in sub-rule (1),-

(i) in clause (a), for the words "any order" the words and symbol "Demand Notice/Adjudication Order" shall be substituted.;

(ii) in clause (c), for the words "five hundred", the words "one thousand" shall be substituted.;

(12) after rule 103, the following rules shall be inserted, namely:

"103A. Transfer of Letter of Intent.- In the event of demise of the applicant for quarrying permit/quarrying lease, the Letter of Intent granted in favour of him/her legal heirs/permitted assigns on production of documents as stipulated under this rules";



(13) in rule 106, in sub-rule (1),-

(i) after the existing proviso the following proviso shall be inserted, namely:-

“Provided further that in the event of failure to complete at least the construction of the basement of the residential building within two years from the date of issuance of the movement permit, the act of extraction of minor mineral under the pretext of construction of the residential building shall be treated as an offence and the residential building permit holder shall be liable to pay an amount equal to five times the royalty remitted for obtaining movement permit in addition to the amount already paid.”;

(ii) in the explanation, after the words and symbol "recognized educational institutions," the words and symbols "ponds attached to temples, hospitals, burial grounds," shall be inserted;

(14) after rule 116, the following rule shall be inserted, namely:-

"117. Star rating system for quarries.- The Government, for evaluating and recognizing mining operations based on their implementation of Sustainable Development Framework (SDF), may implement a star rating system for quarries. The system uses a five-star scale, with higher ratings indicating better performance in areas like environmental management, social responsibility, and operational efficiency. In such cases the quarrying lease holder / quarrying permit holder may submit a duly filled self assessment template as given in Annexure -1 and the evaluation and recognition of the quarry may be done by a Committee as notified by the Government from time to time.";

(15) in Form A, in item No. 2, for the symbols, figure, bracket and words "₹ 1,000 (Rupees One thousand only)", the symbols, figure, bracket and words "₹ 5,000 (Rupees Five thousand only)" shall be substituted;

(16) in Form B, in item No. 2, for the symbols, figure and word, "₹ 10,000 or ₹ 20,000", the symbols, figure and word, "₹ 20,000 or ₹ 40,000" shall be substituted;

(17) in Form S, in condition No. 1, for the words "one year", the words, "two years" shall be substituted;

(18) in Form T, in item No. 4, for the words "one year", the words, "two years" shall be substituted;

(19) after Form U, the following Forms shall be added, namely:-

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to revise the fees as it requires the revision periodically. The time for the construction of basement of the building is increased from one year to two years to alleviate the technical impediments in completing the procedure against the offenders. The same made applicable to those applying for mineral removal for the construction of residential building under rule 106 and a penalty has been imposed for the defaulters who has not constructed atleast the basement of the residential building. Fees has been imposed for the approval of mining plan, scheme of mining and mine closure plan. A star rating system has been introduced for quarries, such as the one implemented by the Indian Bureau of Mines (IBM) for evaluating and recognizing mining operations based on their implementation of Sustainable Development Framework (SDF). In the above circumstances, the Government have decided to make suitable amendment in the Kerala Minor Mineral Concession Rules, 2015 issued by notification under G.O.(P) No.16/2015/ID. dated 7<sup>th</sup> February, 2015 and published as S.R.O. No. 72/2015 in the Kerala Gazette Extraordinary No. 288 dated 7<sup>th</sup> February, 2015.

The notification is intended to achieve the above object.
